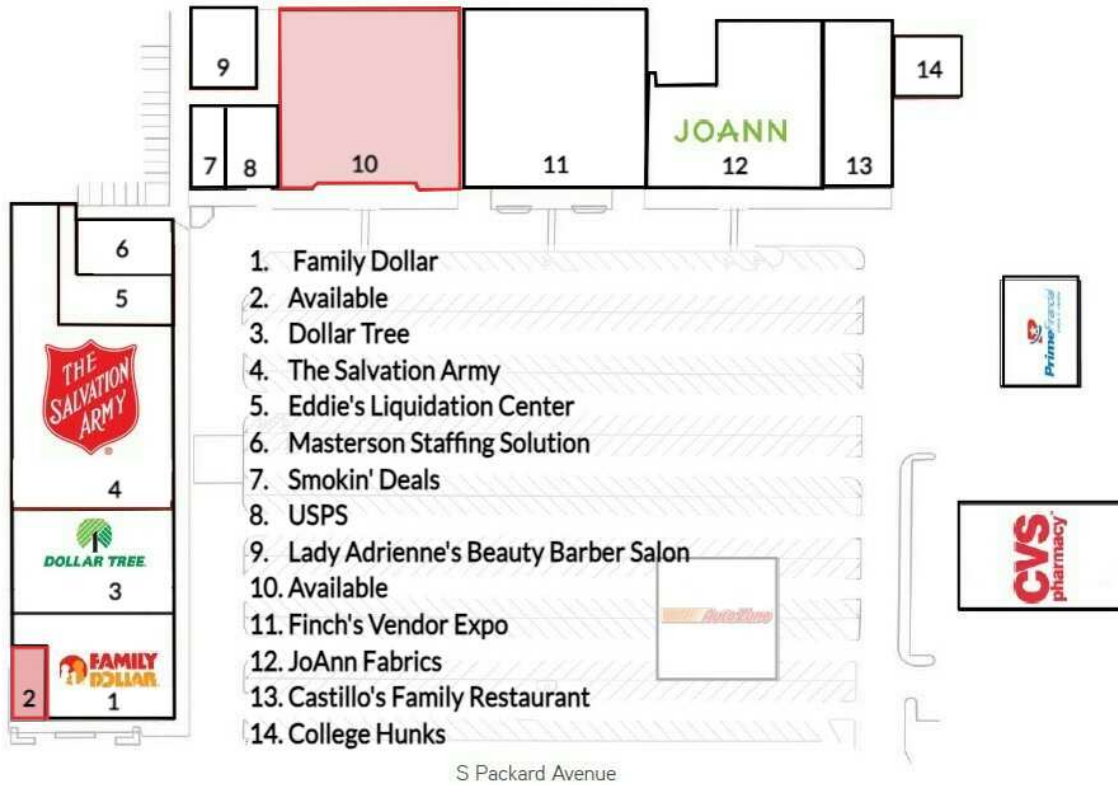
North Side of Strip Center

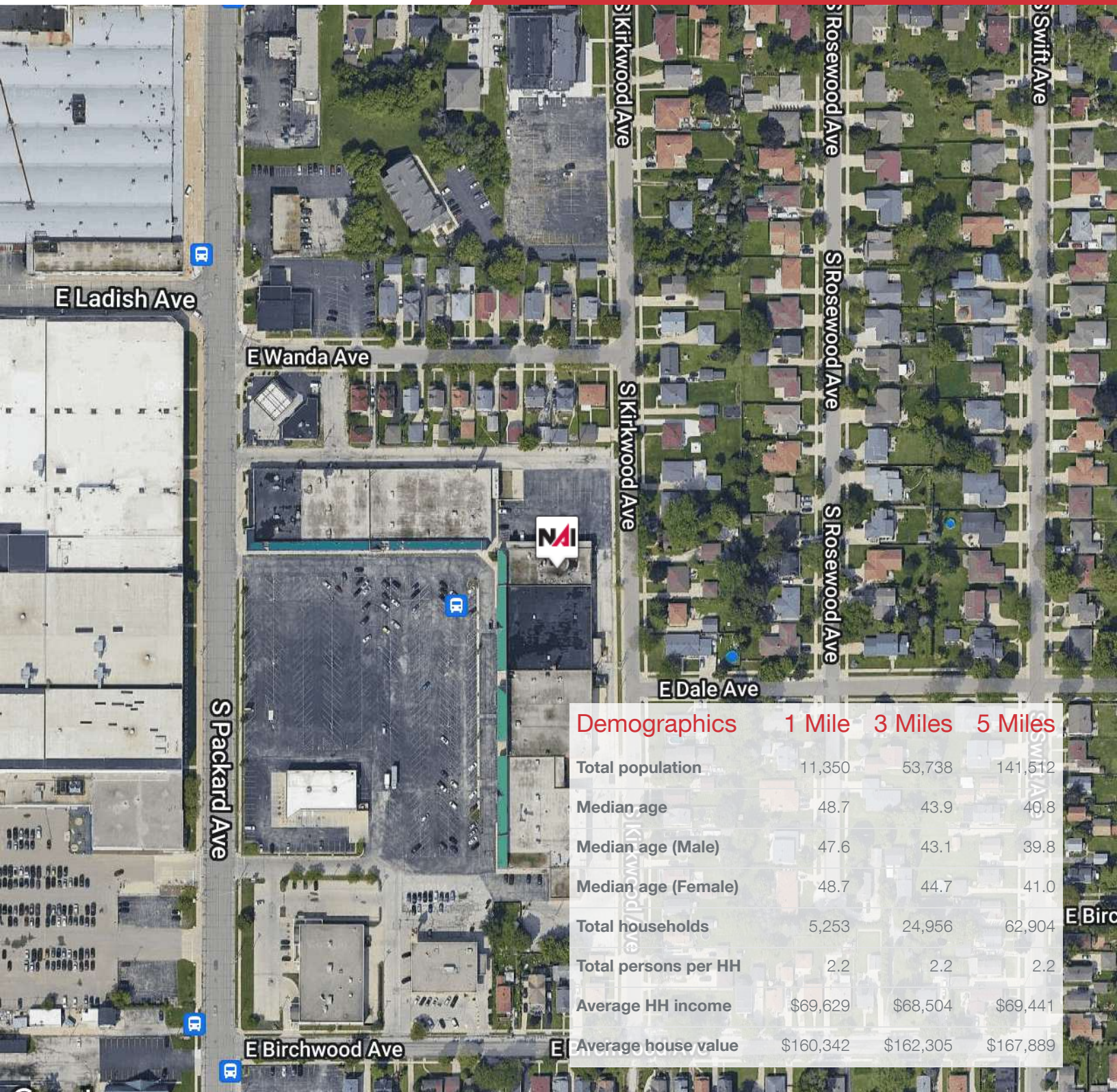

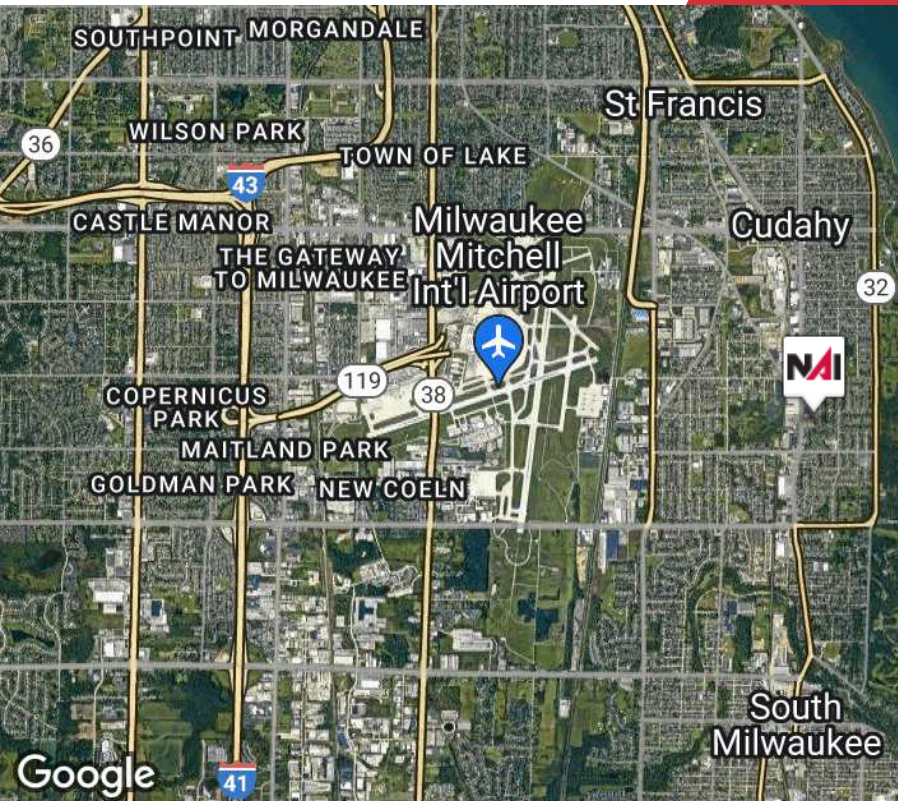

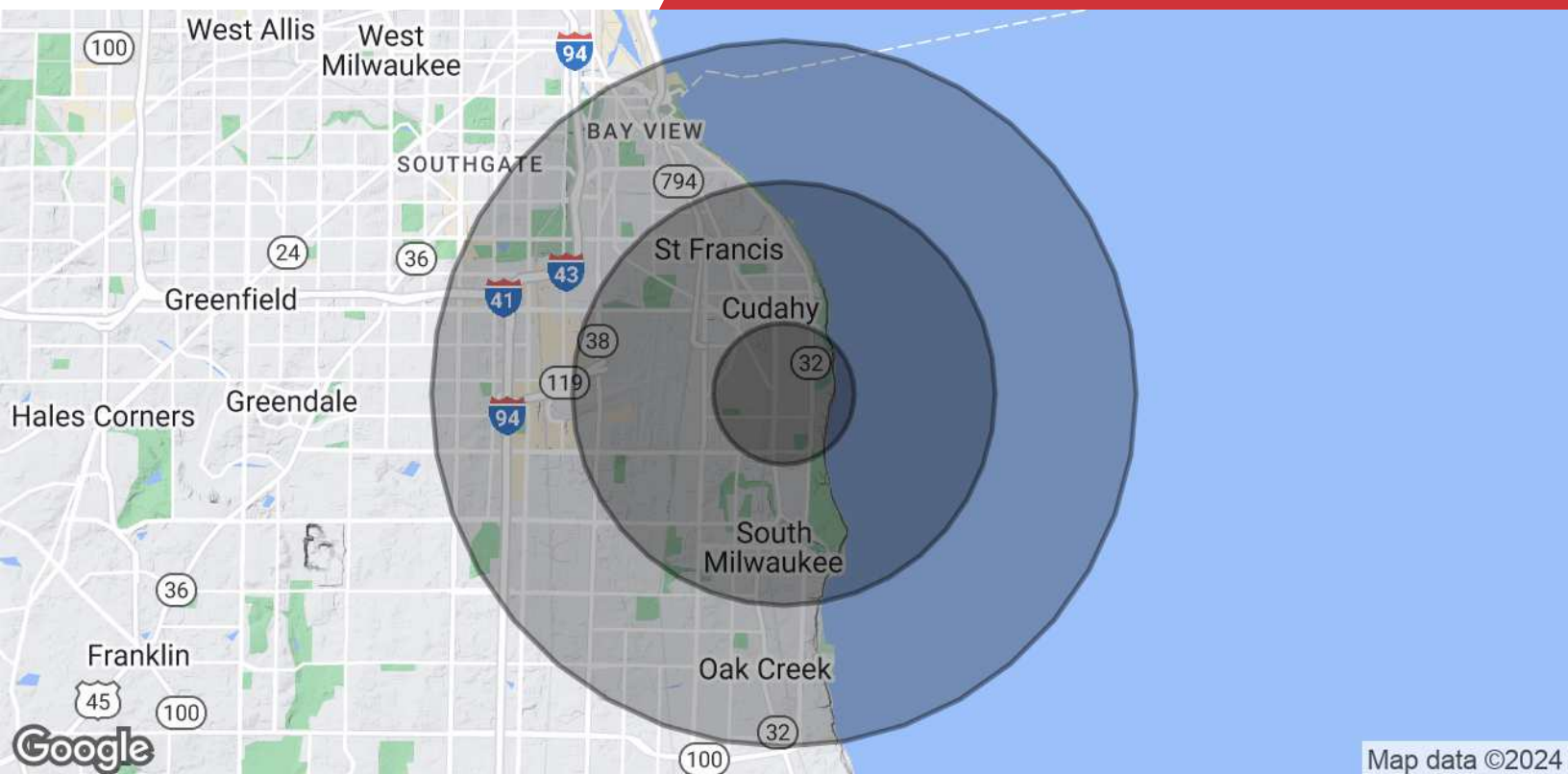
