84South is a 48-acre mixed-use development positioned within the Southridge Mall Regional Trade Area. 84South features over 350,000 square feet of retail and restaurant space, a 135,000-square foot medical center, a 268-unit luxury apartment complex, and multiple outparcels offering casual dining and specialty service-based uses.

The site is accessed via curb cuts along 84th Street, Layton Avenue, and 92nd Street, with the main entrance controlled via a traffic signal off Layton Avenue. Additionally, 84South features almost half a mile of unobstructed visibility from I-894 and is positioned at the 84th Street interchange.

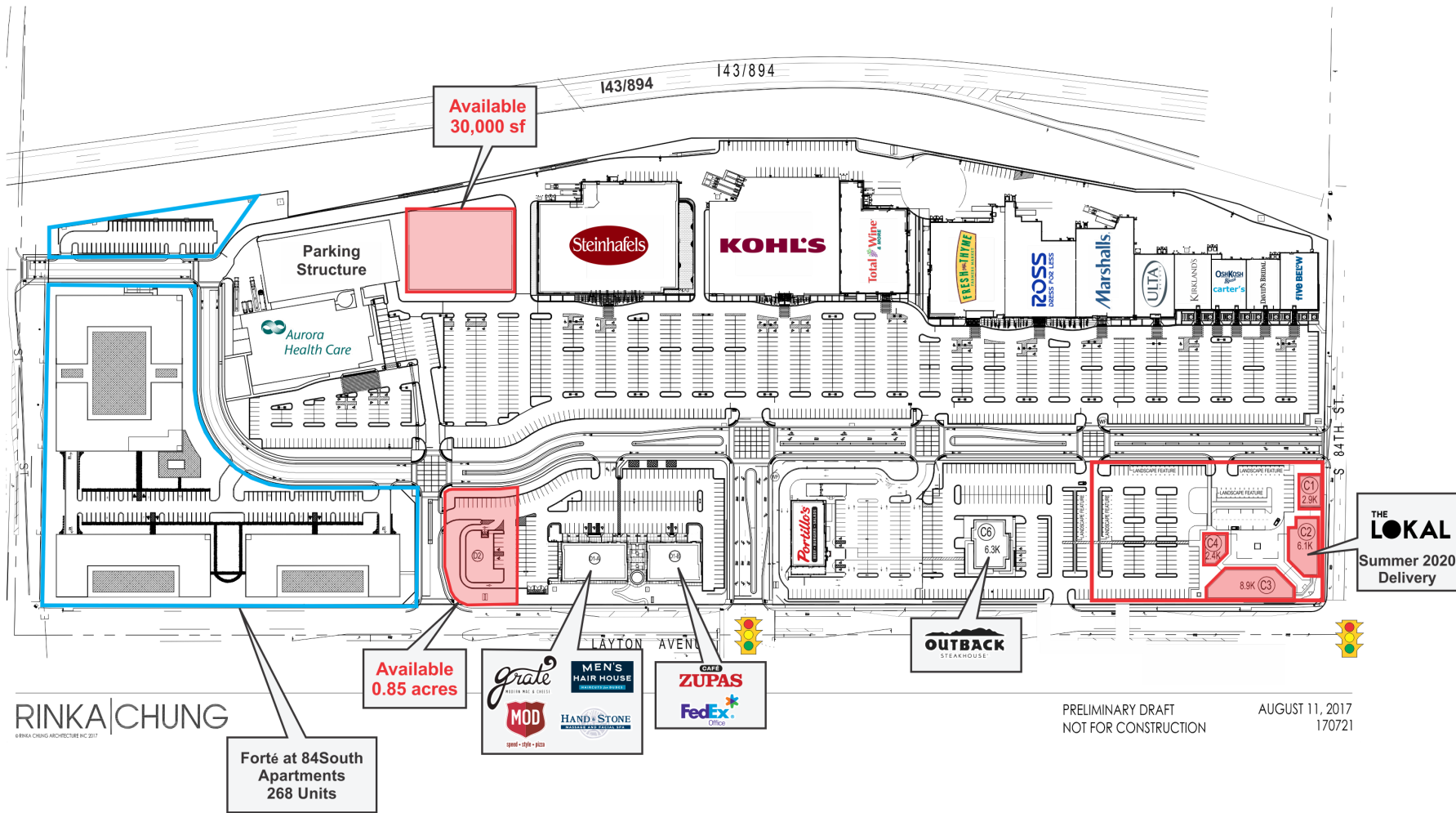

## **BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS**
