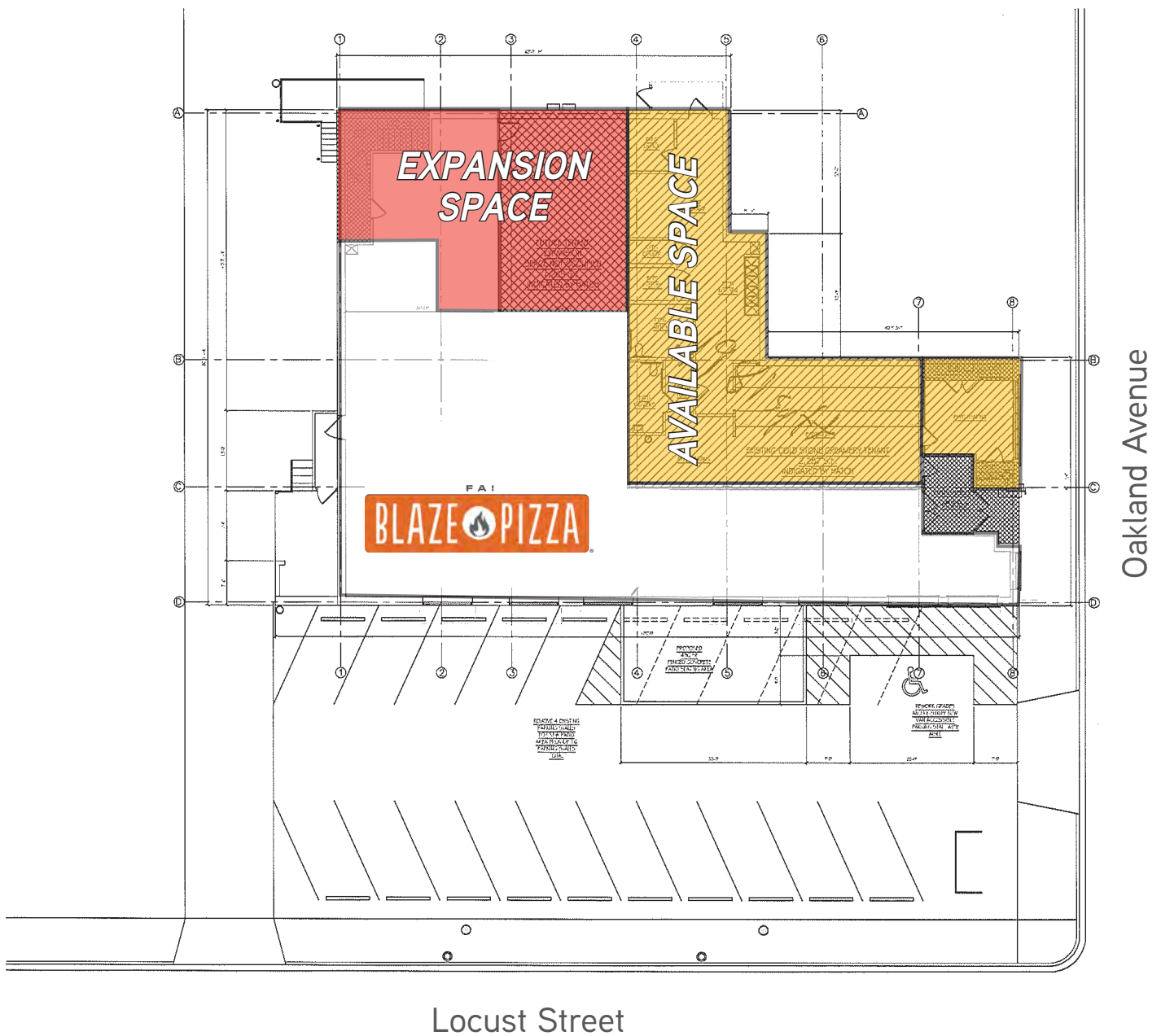
Site Plan

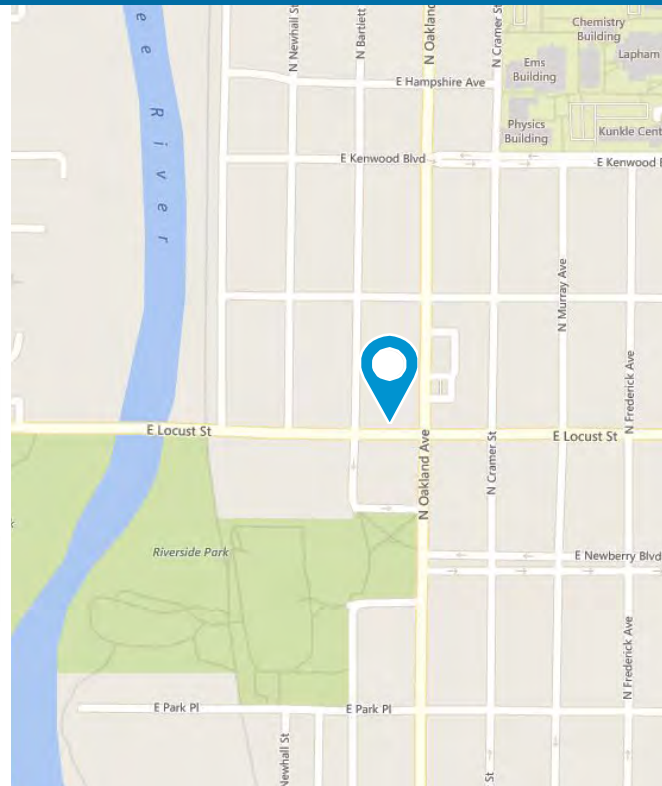
