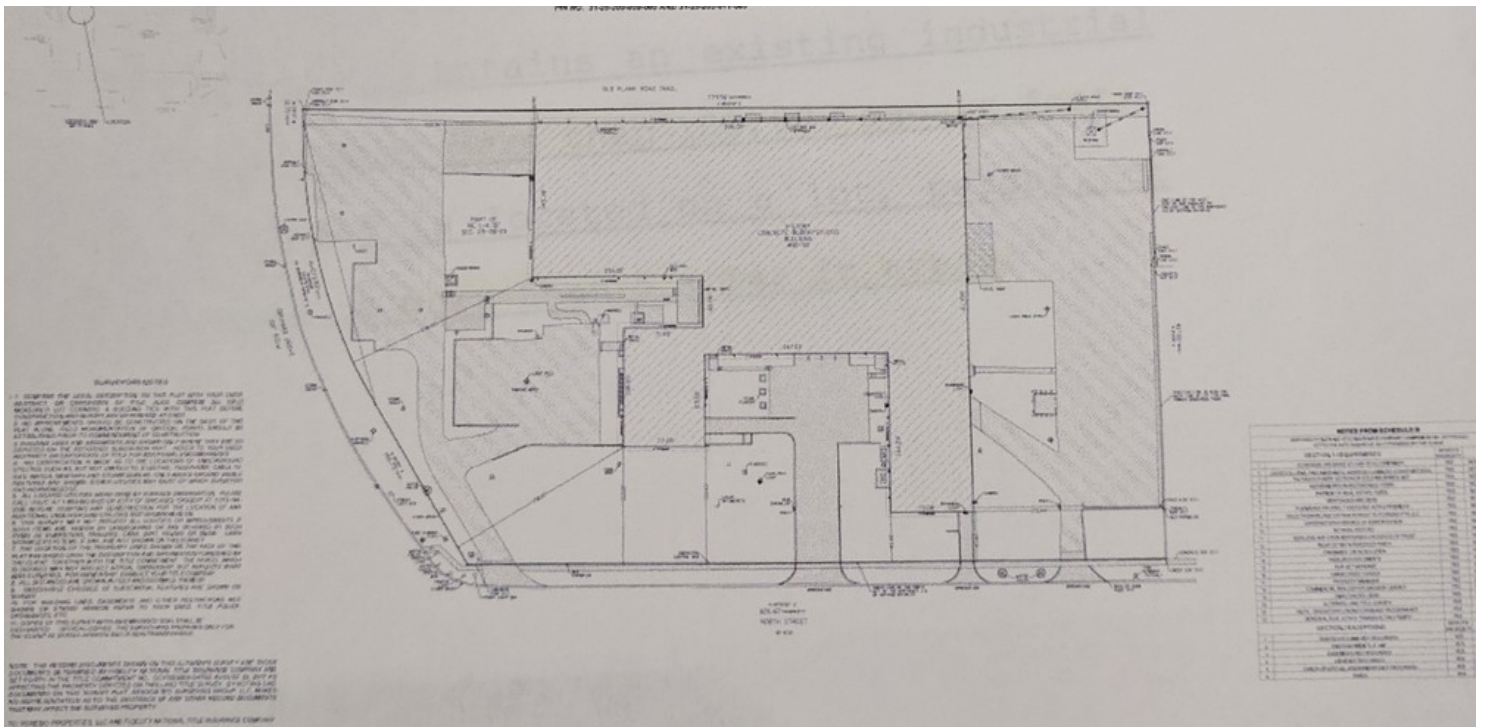

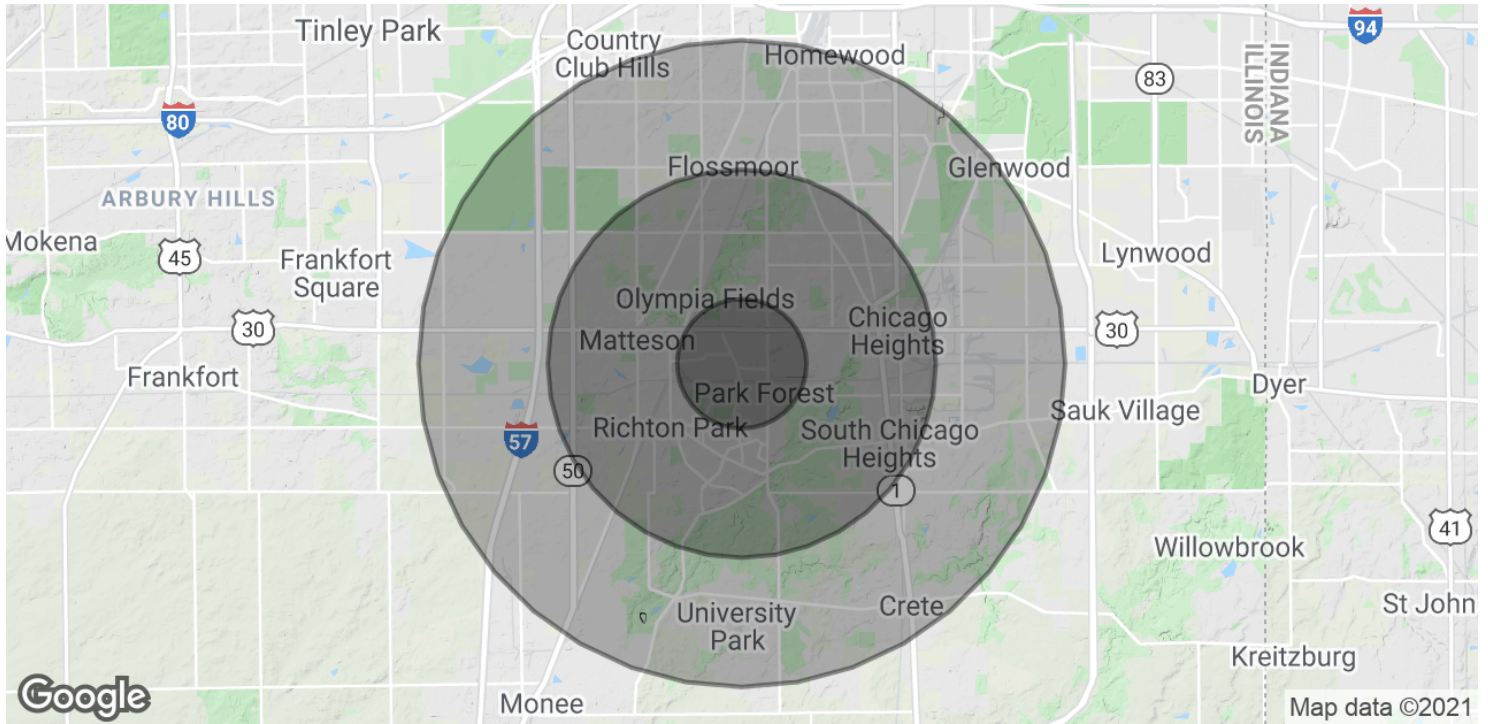
# Site Aerial And Floor Plan
