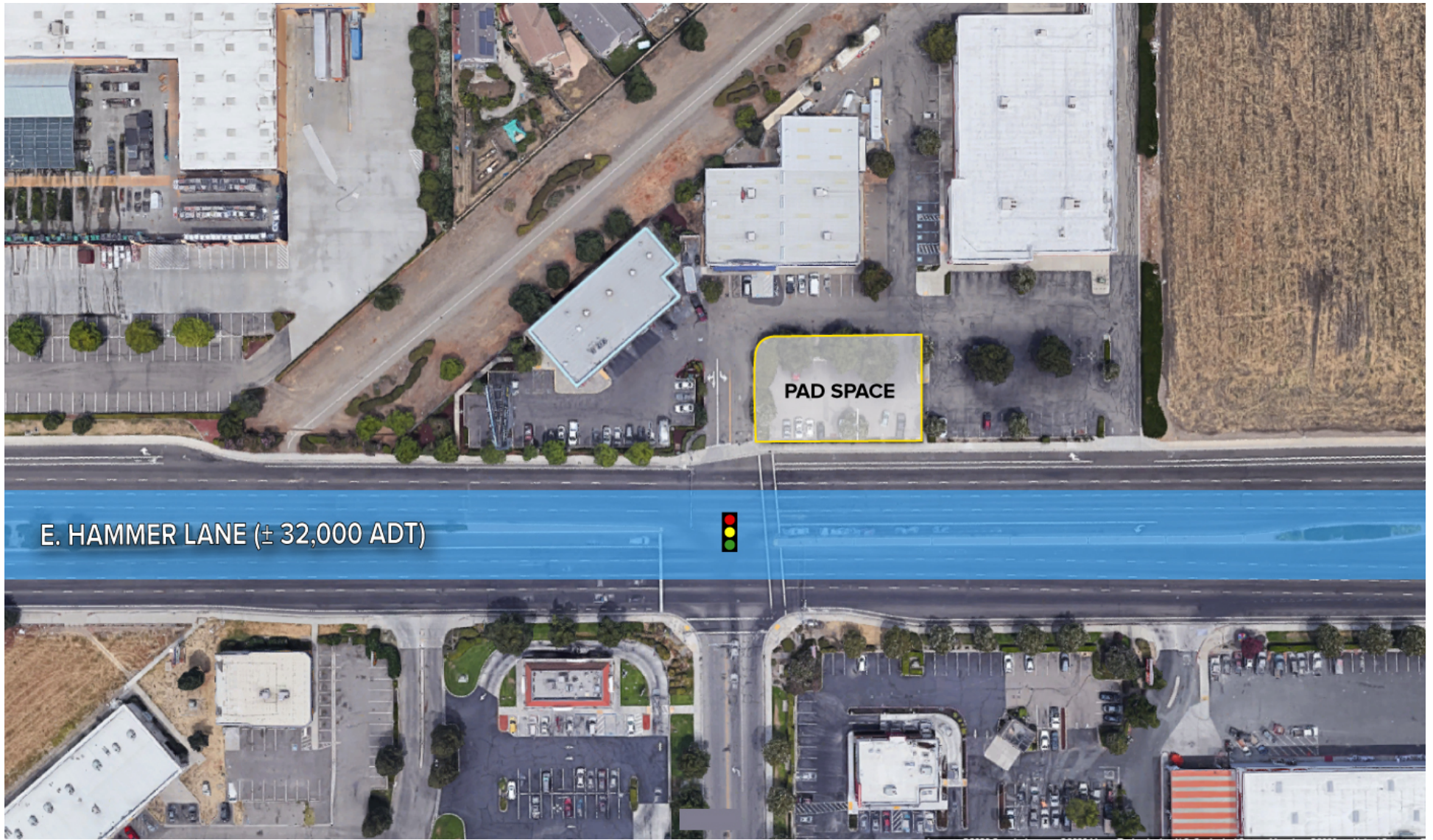

- Within a 5-mile radius there is a population of ± 239,665 with an average household income of \$75,791



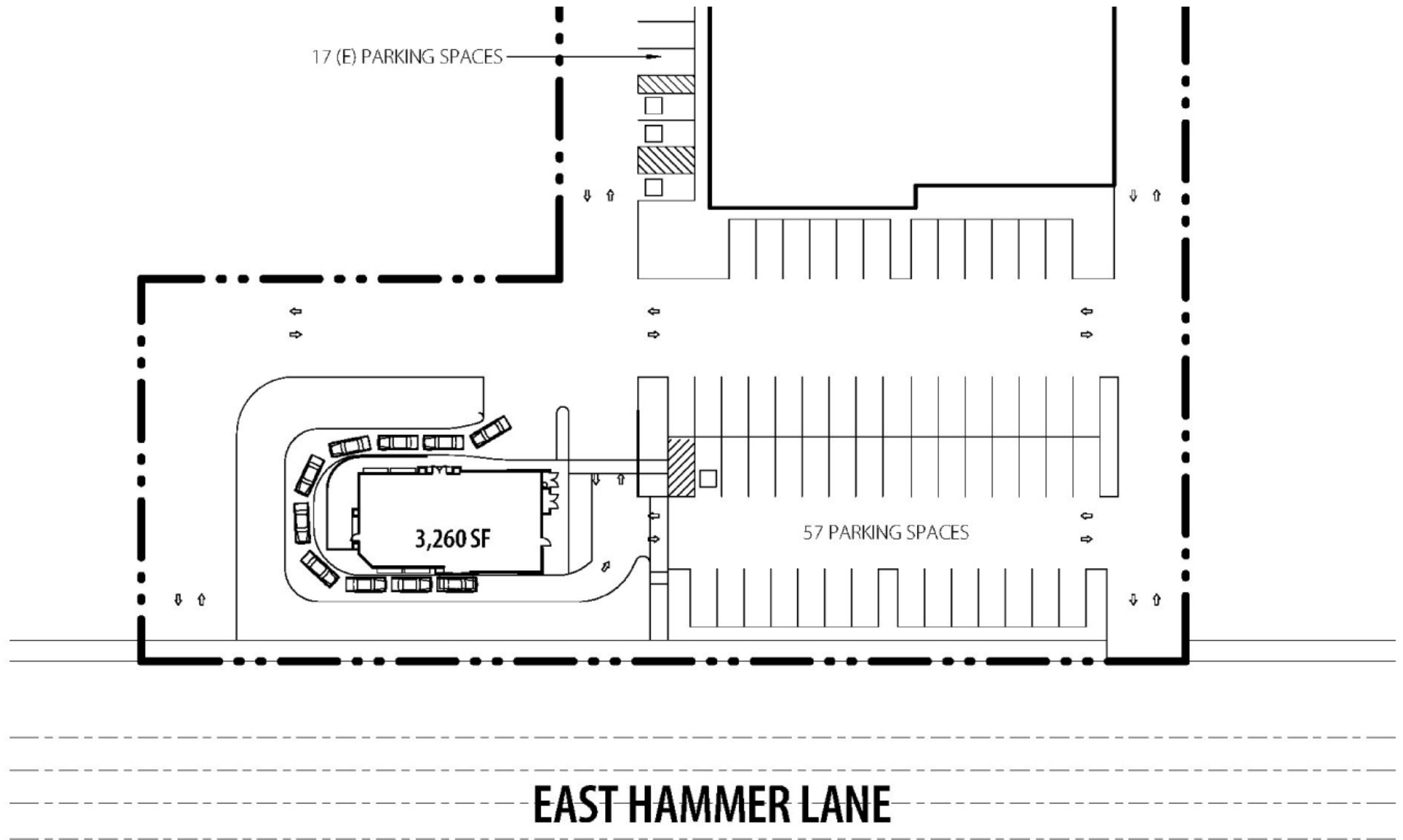
Market View
