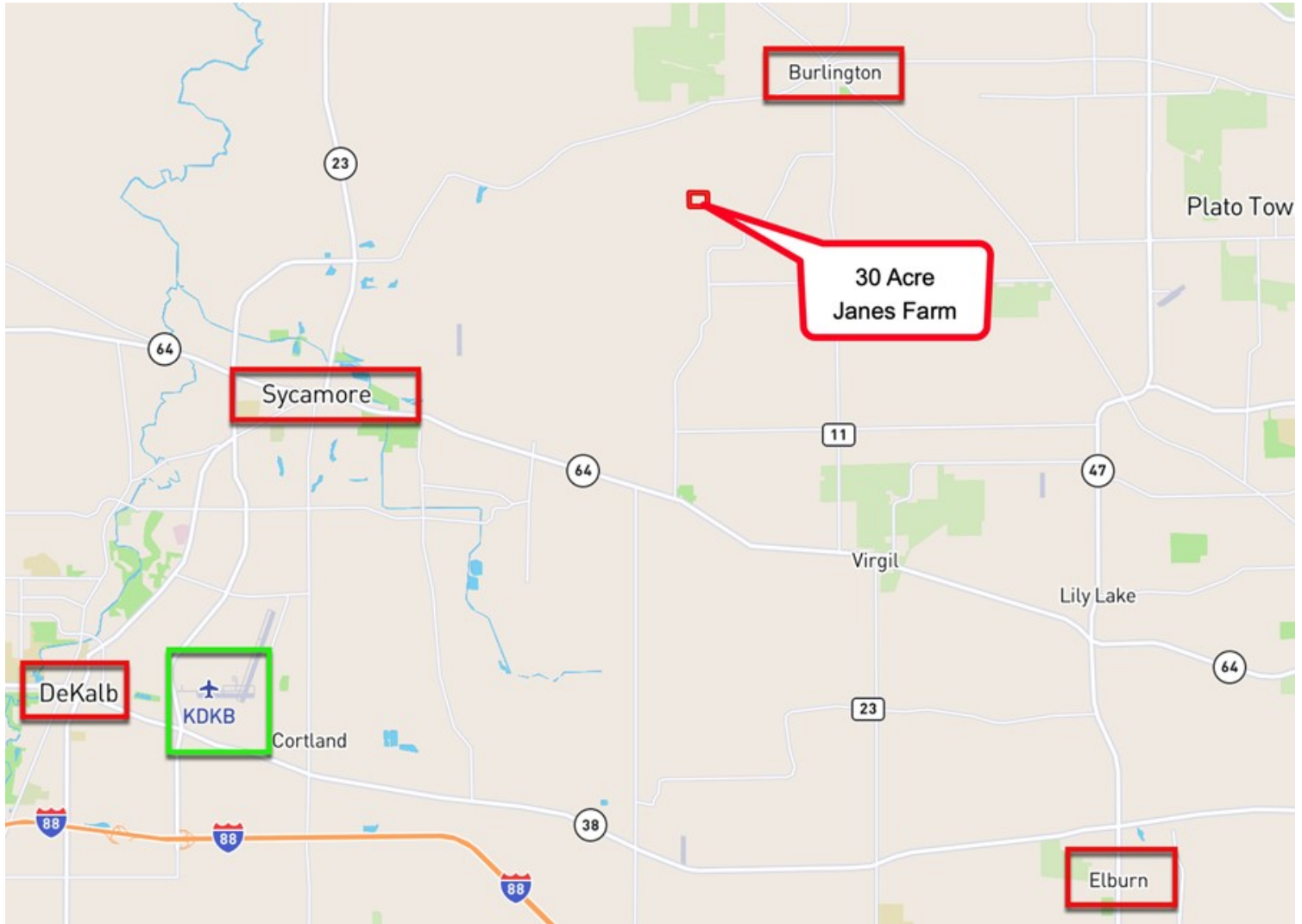

ROADWAYS MAP 30 ACRE JANES FARM BURLINGTON TOWNSHIP, KANE COUNTY



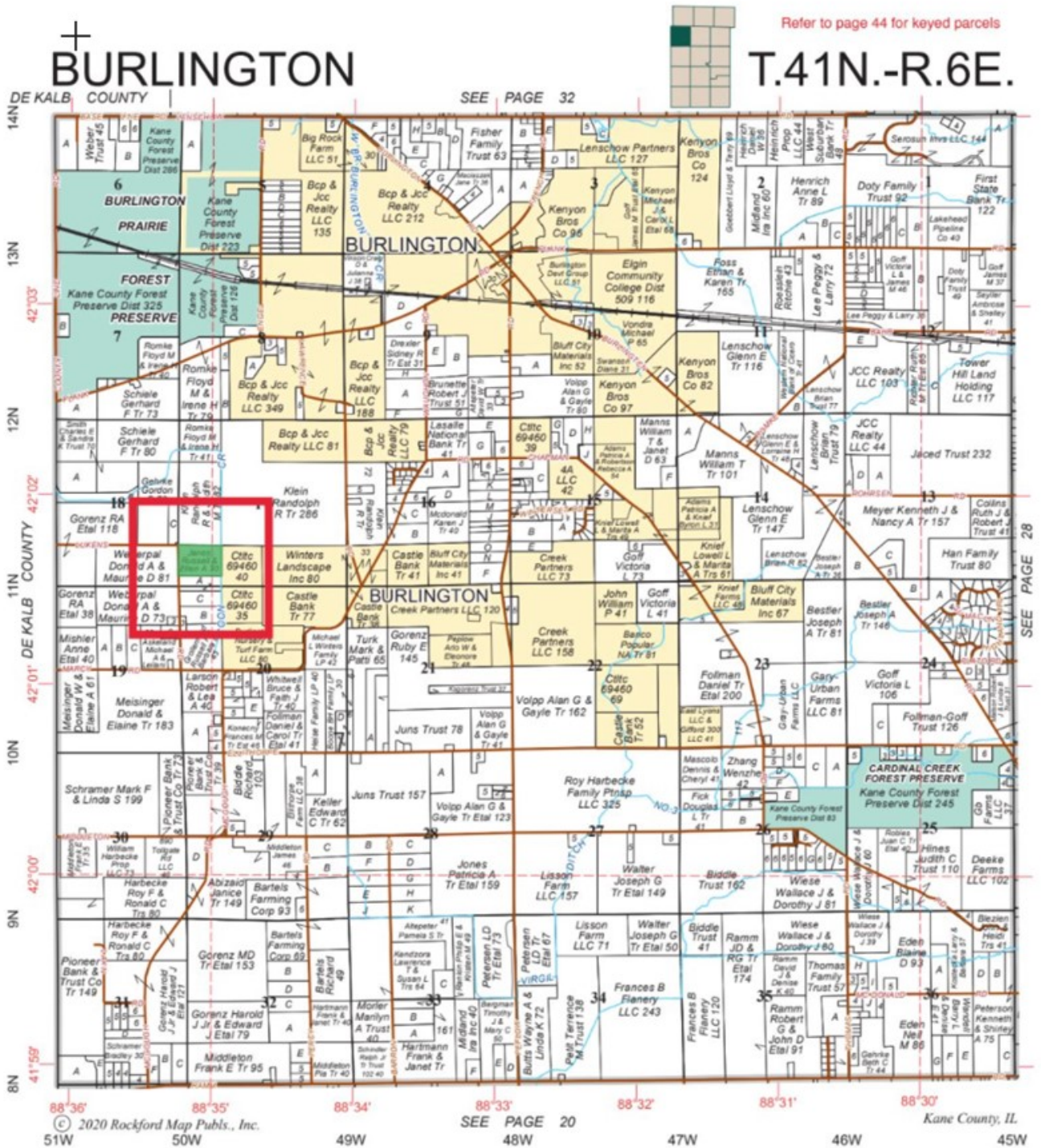
AREA MAP 30 ACRE JANES FARM BURLINGTON TOWNSHIP, KANE COUNTY

PLAT MAP 30 ACRE JANES FARM BURLINGTON TOWNSHIP, KANE COUNTY



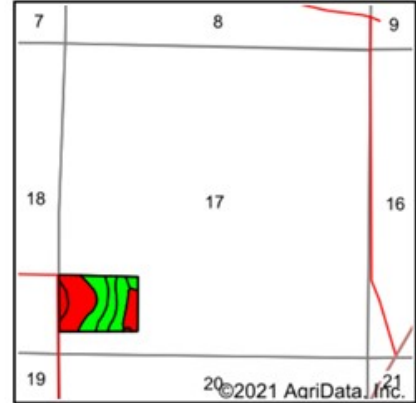
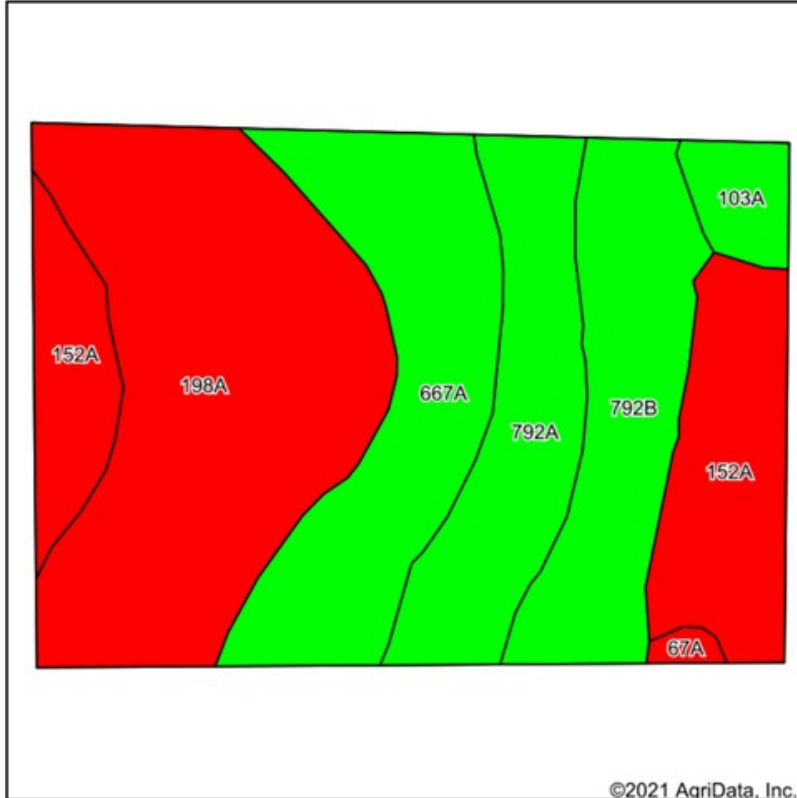

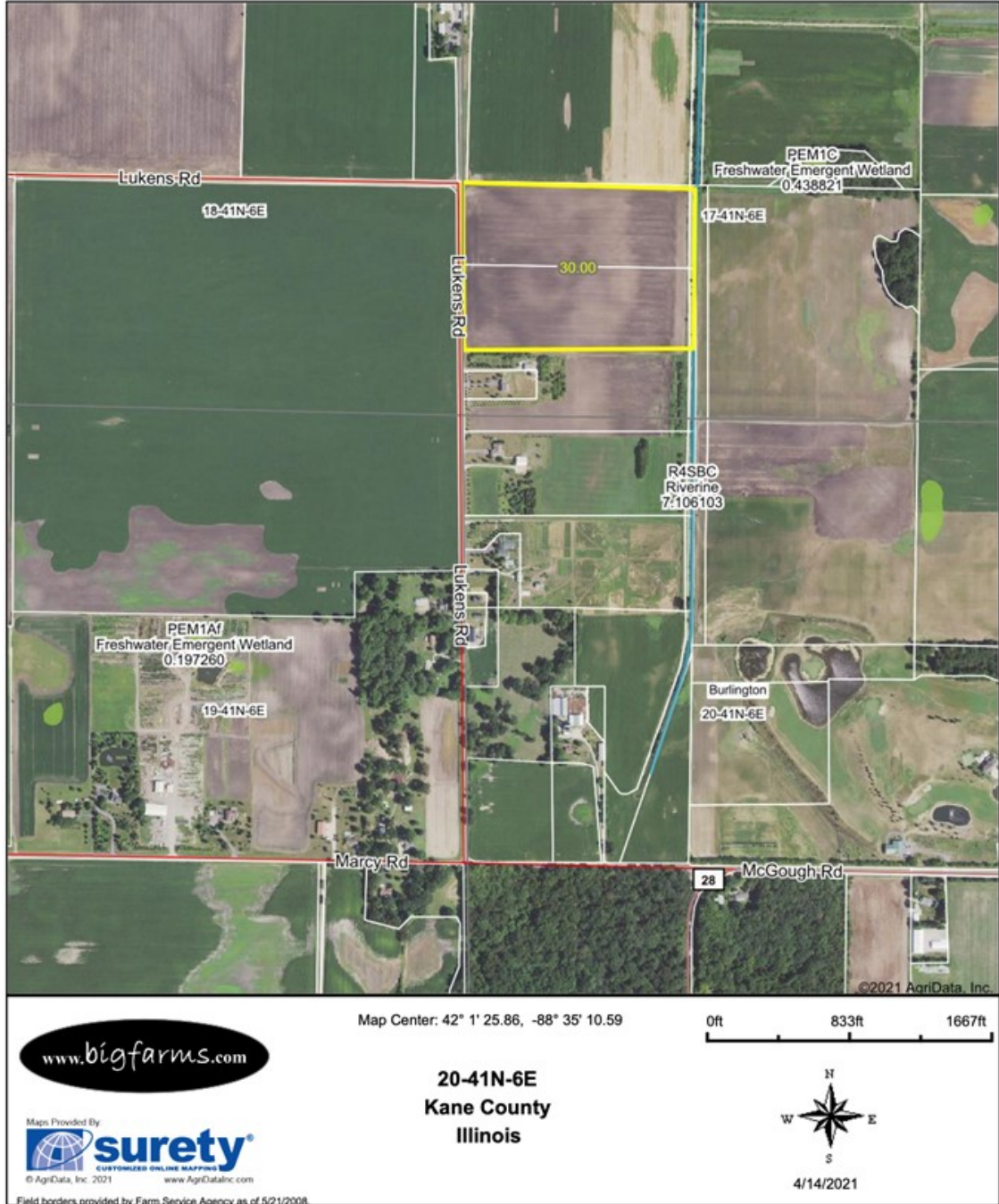

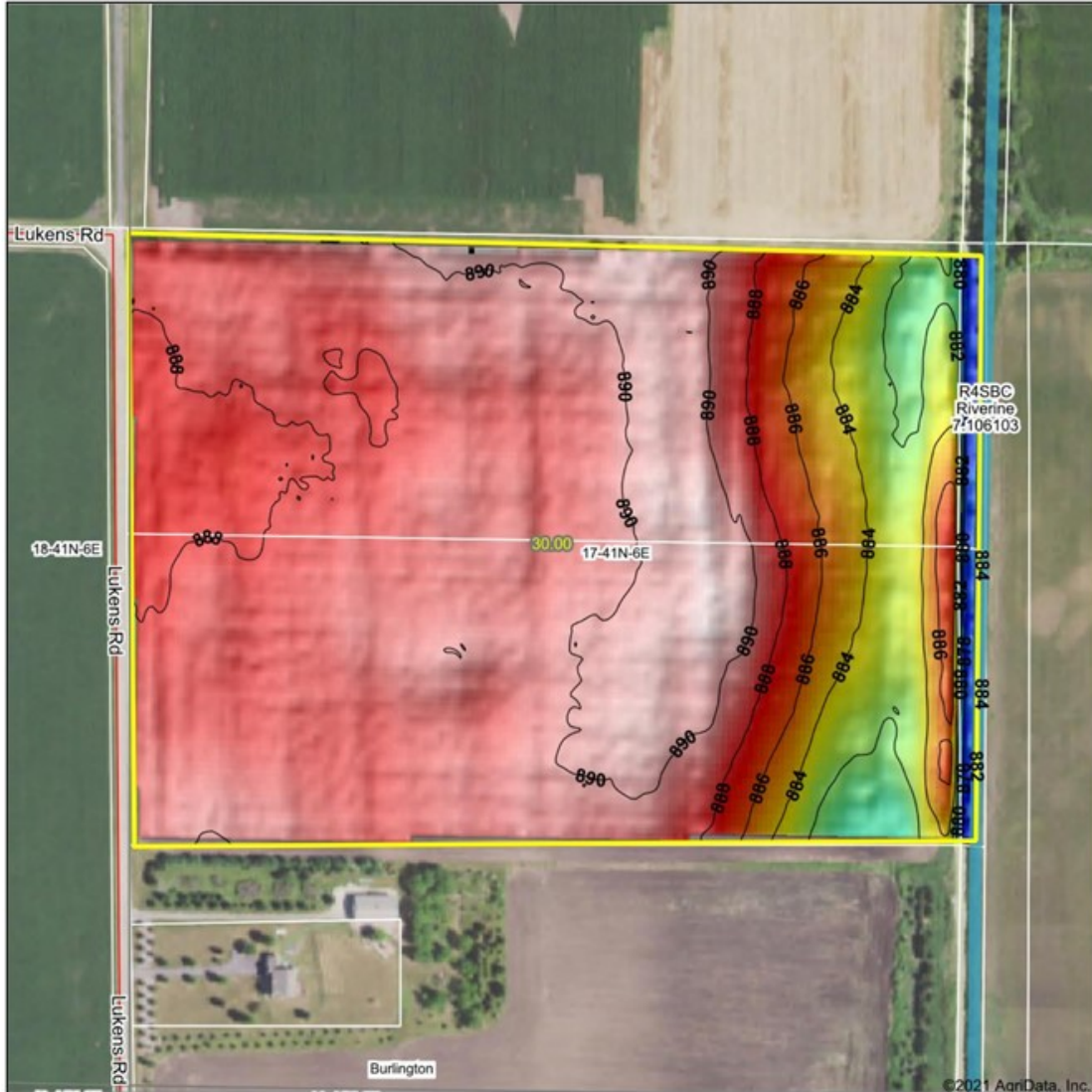

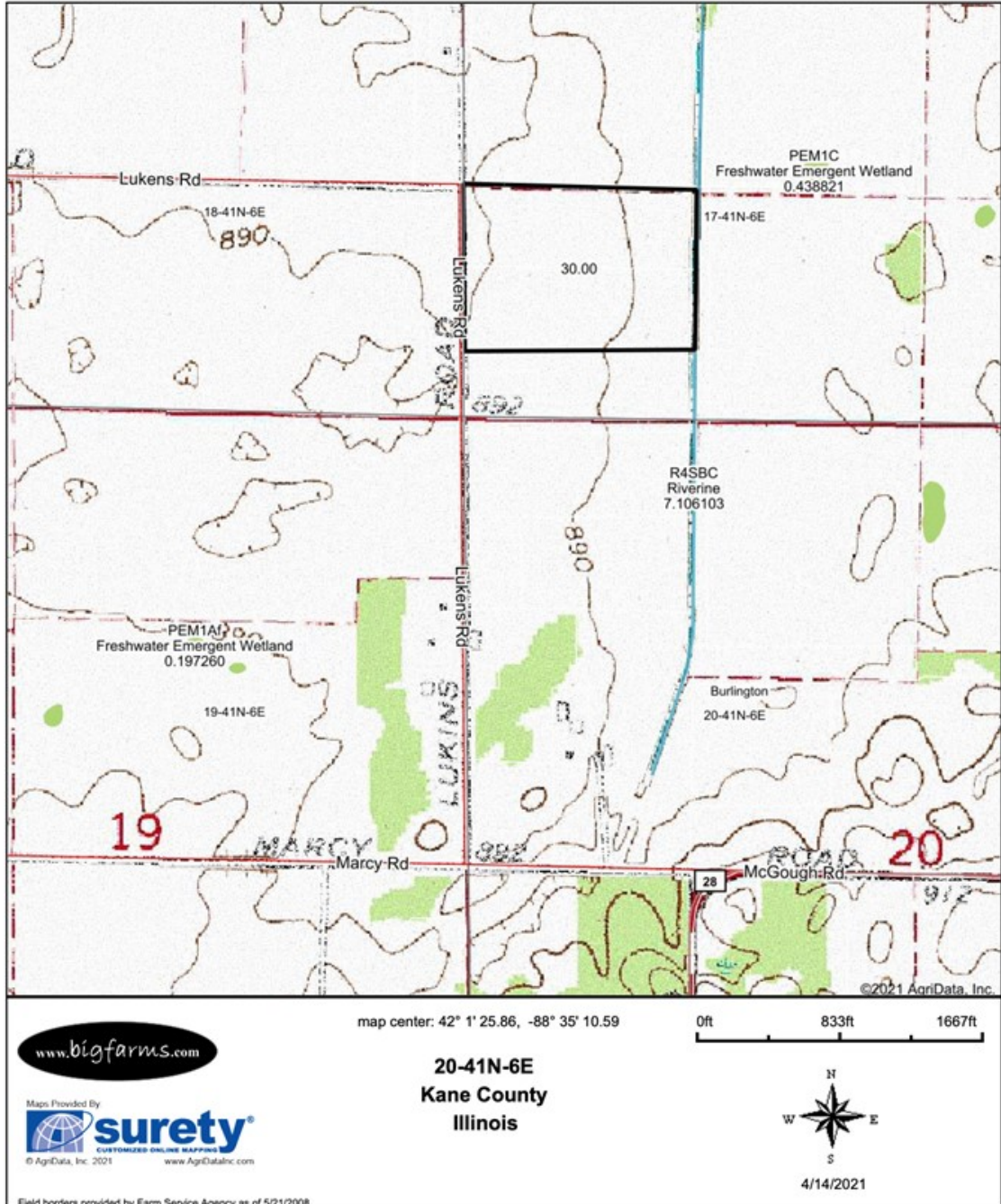

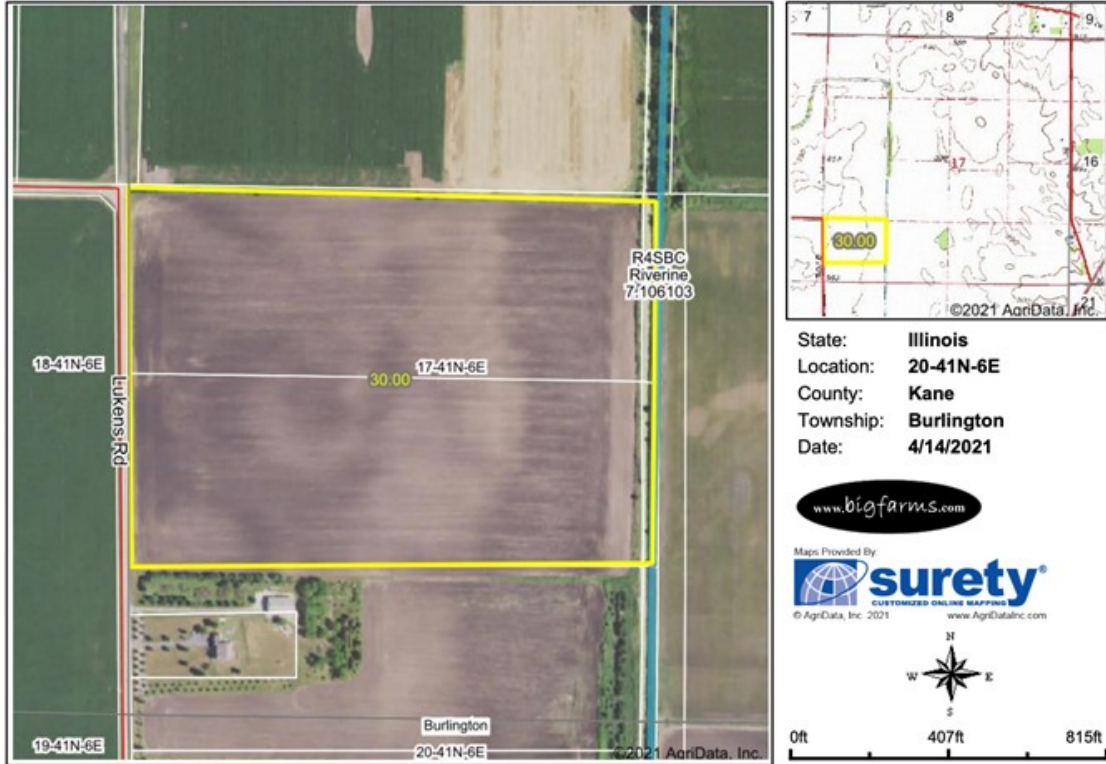
TOPOGRAPHY MAP 30 ACRE JANES FARM BURLINGTON TOWNSHIP, KANE COUNTY

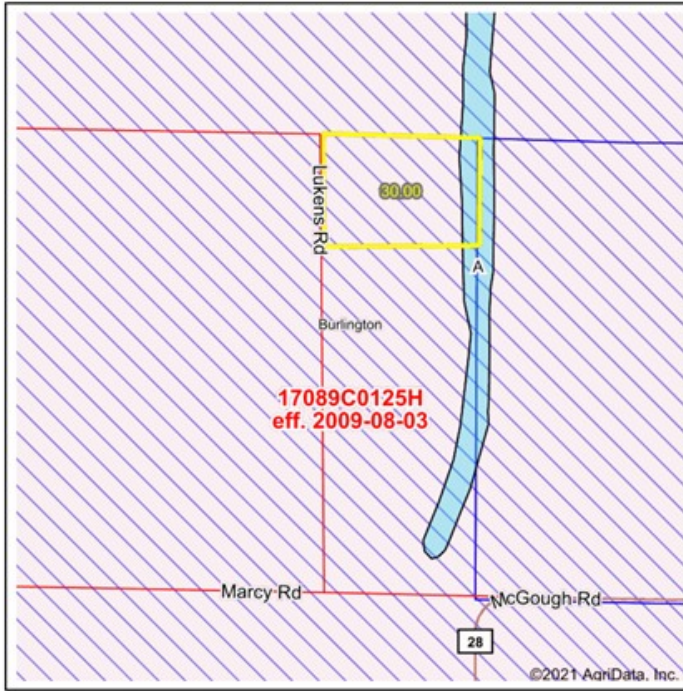
