Going Green at Schilling Green II

- Enhanced building envelope utilizing superior insulation and Low-E glass, as well as energy-efficient packaged rooftop units and high performance lighting, which decreases energy consumption.
- 95% of the construction and demolition waste diverted from landfills.
- More than 30% of the building materials used contained recycled content.
- Two electric vehicle charging stations and 17 hybrid vehicle parking spots, promoting the use of fuel-efficient vehicles in an attempt to reduce pollution from automobiles.
- Water bottle filling stations helping to reduce disposable plastic bottle waste in the environment.

- Low VOC building materials, underfloor air distribution systems and CO2 monitors enhance indoor air quality of the building, which directly impacts worker health and productivity.
- Irrigation water use reduced by 59% by way of weather stations, efficient heads and drought-tolerant landscaping.
- Potable water usage reduced by 48% via water-efficient restroom fixtures.
- Includes 25 kW photovoltaic array and a solar hot water collector to heat the building's domestic hot water, reducing energy use.
- Green housekeeping which ensures that cleaning products and chemicals are used properly and reduces indoor air contaminants produced by cleaning chemicals.


