PROJECT OVERVIEW

7168 Bryhawke Circle is a +/-12,704 SF warehouse built in 2003 on +/-1 acre of M-1 Light Industrial land in North Charleston. Suite A is approximately 7,000 SF and is comprised of +/-5,800 SF of warehouse and +/- 1,200 SF of renovated office space with frontage on Bryhawke Circle. The office is broken into two (2) floors measuring approximately 600 SF each. The first floor features a large entry area, kitchenette, and built-in reception desk while the second floor consists of a large office, storage room, and shower. The warehouse can be viewed from the office with windows on both floors. The warehouse features one (1) 12x14 and one (1) 12x16 drive-in door, three phase power with 200 amps and 200 volts, T8 lighting, compressed air lines, and one (1) renovated bathroom. Suite A has two access points on Bryhawke Circle, with +/- 6 parking spots for customers in front of the building and +/-0.12 acres of paved parking on the north side of the facility. Owner occupies the rear of the building and may have flexibility on more parking and other.





