

## NORTH AMERICAN LIMITED 1-YEAR WARRANTY

Tramec, LLC stands behind our products and will make every effort to assure that our products function in the intended application as designed. Subsequently, we provide a Warranty against defects in workmanship and materials for our products. If at any time during the Warranty period the product fails to perform as designed, the product may be returned directly to Tramec, LLC for a replacement. The following Warranty term is extended to our customers:

## 1-YEAR WARRANTY AGAINST DEFECTS IN MATERIALS AND WORKMANSHIP

**WARRANTY POLICY:** Subject to the terms and conditions set forth herein and the Tramec, LLC terms and conditions of sale, Tramec, LLC offers a Limited Warranty to the original purchaser that the warranted products\* are free from defects in workmanship and/or materials.

Damage from misuse, improper installation, insufficient regular maintenance and upkeep, exposure to harmful solvents or chemicals, unintended application of product, road hazards, abrasion, rips or tears; blunt force damage, or conditions not specified in the appropriate SAE, DOT or other regulatory performance standards is not covered.

This Warranty does not guarantee that the product will last for the Warranty term. Environmental and usage conditions will affect the product life.

Tramec's sole obligation under this Warranty is to replace warranted product to the original purchaser if the product fails because of a defect due to workmanship and/or materials within the limited Warranty period from the original production date. Warranties are not transferable and apply only to the original purchaser of the Tramec, LLC product. Tramec, LLC must approve all claims and our decision whether to approve the claim is final.
