

PUBLIC NOTICE

SP-727B Notice of Readoption N.J.A.C. 19:3 Administration, 19:4 District Zoning Regulations, and 19:5 Subdivision Regulations

PLEASE TAKE NOTICE that the New Jersey Sports and Exposition Authority (NJSEA) is proposing to readopt N.J.A.C. 19:3 Administration, 19:4 District Zoning Regulations; and 19:5 Subdivision Regulations, which shall expire on June 23, 2016 pursuant to N.J.A.C. 1:30-6.4(g). The Notice of Readoption will appear in the January 4, 2016 New Jersey Register. Pursuant to Public Law 2015, Chapter 19, the New Jersey Meadowlands Commission (NJMC) has become part of the New Jersey Sports and Exposition Authority (NJSEA), effective February 5, 2015.

Specifically, pursuant to Executive Order No. 66 (1978) and N.J.S.A. 52:14B-5.1, the NJSEA proposes to readopt, with amendment, N.J.A.C. 19:3-1 Rulemaking, 19:3-2 Flood Insurance, 19:3-5 Redevelopment Areas, and 19:3-7 Debarment and Suspension from Contracting; 19:4 District Zoning Regulations; and 19:5 Subdivision Regulations, which shall expire on June 23, 2016 pursuant to N.J.A.C. 1:30-6.4(g). N.J.A.C. 19:3-3 Disability Discrimination Procedure, required under 42 USC 12-101 et seq. is exempt from expiration pursuant to N.J.S.A. 52:14B-5.1(e). N.J.A.C. 19:3-4 Professional Services Contracts will be allowed to sunset pursuant to N.J.S.A. 52:14B-5.1(c).

The NJSEA has reviewed the current chapter regulations and determined that the rules remain necessary, reasonable, adequate, efficient, understandable and responsive for the purpose for which they was originally promulgated. The readoption is an administrative measure and one amendment is proposed. A non-substantive technical change to N.J.A.C. 19:4-5.115, stemming from the merger of the NJMC and the NJSEA, is required to correct a cross-reference to the words "NJMC regulations" within the rules governing land exemptions in the Sports and Exposition zone.

TAKE FURTHER NOTICE that the NJSEA is accepting written public comment on the proposed readoption with amendment through March 4, 2016. Written comments shall be submitted by the close of business on March 4, 2016 to:
