## **Ohio REALTORS Membership Dues**

Ohio REALTORS 2026 membership dues are \$295 per REALTOR which includes a \$35 Political Advocacy assessment, \$5 Issues Mobilization assessment, \$5 Consumer Communication assessment, \$5 We Stand Initiative, and \$3 Building Improvement. A \$50 New Member Fee is charged to all new members.

Dues will be prorated monthly, based on join date. However, the Political Advocacy Fund assessment (\$35), Issues Mobilization fund (\$5), the We Stand Leadership Fund allocation (\$5), the Building Remodeling Fund allocation (\$3), the Consumer Communications fund (\$5) and the New Member Fee (\$50) are not prorated. NAR Membership Dues National Association of REALTORS 2026 membership dues are \$156 per REALTOR member. NAR's Special Assessment for the Public Awareness Campaign is \$45 and will not be prorated. The Special Assessment is not charged to Brokers for non-member. NAR dues can be prorated monthly for new members, based upon the month they join.

The NAR Board of Directors at its annual meeting on June 5, 2025, approved NAR's 2026 budget which keeps the NAR dues unchanged at \$156/annual and \$45/annual special assessment for the Consumer Ad

Campaign. The approved budget also reallocates \$35 of the special assessment for NAR's general operating account. The remaining \$10 will go towards the Consumer Ad Campaign.

Members who paid in the previous calendar year and paid dues for that year, and for any reason their membership was dropped in that year, and they then return the next year, you should not change their Join Date and their dues may not be prorated.

The waiver of Ohio REALTORS and NAR dues for members and their spouses called into active military duty has been extended to cover dues for the year ending December 31, 2026.
