




Important Dates:

- **February 21:** Ohio REALTORS® Dues Deadline.
- **March 13:** Posting date for dues received by February 21.
- **March 16:** List of delinquent members sent to Local Boards.
- **April 1:** Penalty for those Local Boards/Associations not 95% paid and no Directors vote at next Directors' meeting. Local Boards/Associations not 95% not paid will forfeit entitlement to administrative fee.
- **April 15:** Administrative fee checks mailed to Local Boards/Associations that met 95% dues obligation by April 1.

Ohio REALTORS® 2026 Membership Dues

Ohio REALTORS® 2026 membership dues are **\$295 per member**. This total includes annual dues, assessments, and non-operating funding.

Breakdown:

- **\$250** – Base Dues
(Includes \$8 redirected to non-operating funding)
- **\$35** – Political Advocacy Fund
- **\$5** – Issues Mobilization Fund
- **\$5** – Consumer Communications Fund

Dues & Assessments

Local, State, and National dues are prorated monthly based on the member's join date, unless otherwise noted below.

Not Prorated

The following fees and assessments are **not prorated**:

- Political Advocacy Fund – \$35
- Issues Mobilization Fund – \$5
- Consumer Communications Fund – \$5
- We Stand Leadership Fund – \$5
- Building Remodeling Fund – \$3
- New Member Fee – \$50 (charged to new members only)

National Association of REALTORS® (NAR) Dues

- 2026 NAR Membership Dues: **\$156 per REALTOR® member**
- NAR dues **are prorated monthly for new members** based on the month they join.
- The **\$45 Public Awareness Campaign Special Assessment is not prorated.**
- The Special Assessment is **not charged to brokers for non-members.**
- The waiver of Ohio REALTORS® and NAR dues for members and their spouses called into active military duty has been extended to cover dues for the year ending December 31, 2026.
