Travel for companions- Travel for companions is permitted only when the companion's travel is directly in furtherance of the College's business purposes. Tax indemnification and gross-up payments- Payments are made on the President's behalf relating to personal insurance policies and are included in his imputed income. The College grosses-up this amount to off-set the impact on net pay. Housing allowance or residence- Housing is provided to the President as a required condition of employment. All benefits were provided in accordance with written College policies. None of the benefits were treated as taxable compensation in accordance with applicable law.
