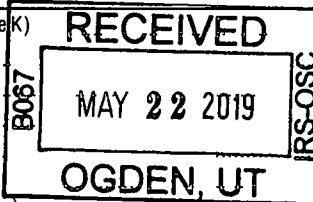

The Organization timely filed an extension for Form 990-T based on preliminary analysis conducted regarding the disallowance of certain qualified transportation fringe benefits pursuant to IRC Sec. 512(a)(7). Upon receipt of IRS Notice 2018-99, the Organization concluded they in fact are not subject to the tax imposed by IRC Sec. 512(a)(7) as the Organization meets the general public "primary use" exception as described in IRS Notice 2018-99.
