During calendar year 2017, Douglas F. Dean, an officer of the filing organization, participated in the plan. A defined contribution in the amount of \$28,041 was made to his plan, which is included in Mr. Dean's total compensation reported in Schedule J, Part II, Column B(III) and Form 990, Part VII-A, Column E. Additionally, defined benefit amounts of \$45,977, which includes the actuarial change in value for the year, was included in Schedule J, Part II, Column C and Form 990, Part VII-A, Column F as deferred compensation. The maximum potential incentive payments under the plan are considered by the compensation consultant in ensuring that management compensation is reasonable.

Compensation in the amount of \$109,920 was paid to Martinville, Dunn, LLC during calendar year 2017 by the Hospital for Mr. Rooney's services. Additionally, Mr. Ingold received a housing allowance in the amount of \$7,500 during the calendar year, which is included in the amount paid to Ingold & Associates, LLC. As the fees paid to each LLC were paid for services to the entire related party system, an accurate breakdown of the fees relative to the filing organization is not readily determinable.
