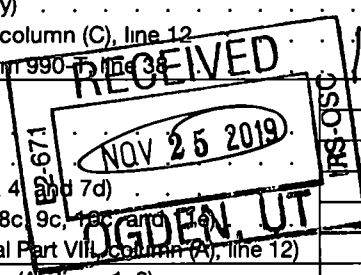

Enable clubs in Indian Country to deliver nutrition education that provides healthy habits; outcome-driven education program to more Native kids and teens; educate train and empower club staff with the knowledge and resources to effectively implement healthy habits in a culturally sensitive and age appropriate way.

Program to keep kids on track to graduate with Spark Early Literacy program and Summer Brain Gain. Clubs offer year round programming that aims to stop learning loss and keep more kids on track to graduate.

The Vista program has been part of a larger support structure for Native clubs that includes funding, training, and technical support. This allowed the organization to ensure that clubs are well supported in their activities including those of Vista volunteers and that programs that Vistas support will sustain beyond the Vista service. Vistas will position clubs to be able to have maximum impact and aid youth to succeed in adulthood; improve program delivery through adaptation of programs to be culturally and locally relevant; ensure sustainability of the local clubs organization through fund seeking tasks.
