1 Briefly describe the organization's mission:

HELPING PEOPLE WITH DISABILITIES BECOME FULL PARTICIPANTS IN THE COMMUNITY; CHOOSING FOR THEMSELVES HOW TO LIVE, LEARN, WORK, SOCIALIZE AND PLAY. NEARC'S SERVICE SCOPE AND THE DEMOGRAPHIC AREA HAVE EXPANDED SIGNIFICANTLY OVER THE PAST SIX DECADES. THE AGENCY CURRENTLY IMPACTS MORE THAN 15,000 PEOPLE ANNUALLY, SERVING INDIVIDUALS WITH DEVELOPMENTAL, INTELLECTUAL AND PHYSICAL DISABILITIES AND THEIR FAMILIES IN 190 COMMUNITIES IN EASTERN MASSACHUSETTS. NEARC PROVIDES OPPORTUNITIES FOR CHILDREN AND ADULTS WITH DISABILITIES TO ATTEND PUBLIC SCHOOLS, DEVELOP FRIENDSHIPS, RESIDE IN THE NEIGHBORHOODS OF THEIR CHOICE, AND TO EARN A PAYCHECK. NORTHEAST ARC IS DIVIDED INTO THREE PROGRAMMATIC DIVISIONS: FAMILY SUPPORT, RESIDENTIAL, AND DAY SERVICES. WITHIN EACH DIVISION ARE UNIQUE PROGRAMS THAT PROVIDE A BROAD SCOPE OF SERVICES, SUPPORTS, ADVOCACY, INFORMATION AND REFERRALS THAT ARE RESPONSIVE TO THE NEEDS OF THE INDIVIDUALS AND FAMILIES SERVED.



EARLY INTERVENTION - TWO EARLY INTERVENTION PROGRAMS OPERATED BY THE NORTHEAST ARC PROVIDE SERVICES TO MORE THAN 1,000 CHILDREN ANNUALLY. THE PROGRAMS PROVIDE FAMILY-FOCUSED, HOME, TELEHEALTH, AND COMMUNITY BASED THERAPEUTIC SERVICES TO CHILDREN AGE 0 TO 3 WHO ARE AT RISK OF ATYPICAL DEVELOPMENT. TRAININGS ARE ALSO PROVIDED TO PARENTS AND PROFESSIONALS IN THE COMMUNITY ON A VARIETY OF TOPICS. COMMUNITY-BASED DAY SERVICES - PROVIDES SKILL-BUILDING ACTIVITIES TO HELP PREPARE PEOPLE FOR JOBS. VOLUNTEER OPPORTUNITIES, COMMUNITY RESOURCES AND ACTIVITIES ARE USED TO AID IN THE DEVELOPMENT OF SOCIAL AND EMPLOYMENT SKILLS. EMPLOYMENT TRAINING & JOB PLACEMENT - THESE SERVICES INCLUDE ASSESSMENT, WORK EXPLORATION, TRAVEL TRAINING, CAREER PLANNING, JOB COACHING, PAID EMPLOYMENT IN NEARC'S SMALL BUSINESSES INCLUDING BREAKING GROUNDS CAF, SHINE JEWELRY, THE CANING COMPANY AT NORTHEAST ARC, AND HERITAGE SHREDDING, AS WELL AS COMPETITIVE JOB PLACEMENT AND SUPPORT. TRANSPORTATION SERVICES - TRANSPORTATION IS PROVIDED FOR INDIVIDUALS WE SERVE IN SEVERAL CAPACITIES. IN BOTH EXTERNAL AND EXTERNAL SUPPORT FUNCTIONS. THIS INCLUDES CONTRACTED DAILY SCHEDULED TRANSPORTATION FROM HOMES TO PROGRAMS, VARIOUS DIRECT OR 'ON-DEMAND' NEEDS OF DAY SERVICES DIVISION, AND OTHER SUPPORT AS REQUESTED AGENCY-WIDE. DAY HABILITATION SERVICES - THE NORTHEAST ARC RUNS THREE DAY HABILITATION PROGRAMS. THESE PROGRAMS PROVIDE ASSISTANCE WITH THE ACQUISITION, RETENTION, AND/OR IMPROVEMENT OF SELF-HELP, SOCIALIZATION, AND ADAPTIVE SKILLS. EACH LOCATION HAS A PARTICULAR FOCUS. SUPPORTS ARE ARRANGED BASED ON A PERSON'S OWN GOALS AND OBJECTIVES, AND EACH PERSON'S DAY HABILITATION PLAN GUIDES HIS OR HER ACTIVITIES. CLINICAL SUPPORTS AND CONSULTATIONS ARE WOVEN INTO PARTICIPANTS' DAILY ACTIVITIES. RNS AND LPNS ARE PART OF EACH OF THE PROGRAMS. A VARIETY OF SUPPORTS AND ACTIVITIES INCLUDE, BUT ARE NOT LIMITED TO: ACTIVITIES OF DAILY LIVING SKILL DEVELOPMENT; COMMUNICATION SUPPORT AND DEVELOPMENT; BEHAVIORAL SUPPORTS; SELF-ADVOCACY; PEER MENTORING; MEDICAL CASE MANAGEMENT; COMMUNITY-BASED ACTIVITIES; ADAPTIVE TECHNOLOGY (IPADS, IPOD TOUCH, SMART BOARD); SOCIALIZATION; HEALTH AND WELLNESS; COMMUNITY OUTREACH IN SUPPORT OF OUR NEIGHBORS; AND PART-TIME WORK OPPORTUNITIES. THE PERSONAL CARE ATTENDANT (PCA) PROGRAM IS A MASSHEALTH SERVICE THAT ALLOWS PEOPLE WITH LONG-TERM DISABILITIES TO LIVE AT HOME INDEPENDENTLY AND MANAGE THEIR OWN CARE. OUR PERSONAL CARE MANAGEMENT (PCM) PROGRAM AT NORTHEAST ARC SERVES MORE THAN 4,700 INDIVIDUALS LIVING IN COMMUNITIES THROUGHOUT NORTHEASTERN MASSACHUSETTS, GREATER BOSTON, AND THE METRO WEST AREA. PCM SKILLS TRAINERS, WITH THE HELP OF A NURSE AND OCCUPATIONAL THERAPIST, ASSESS THE PERSONAL CARE NEEDS OF THE INDIVIDUAL, PREPARE A PCA APPLICATION TO SUBMIT TO THE CONSUMER'S INSURER, AND HELP CONSUMERS IN MANAGING THE HIRING AND TRAINING OF THE PCA AND THE DAILY OPERATIONS OF THE PROGRAM. ADULT FAMILY CARE (ALSO KNOWN AS ADULT FOSTER CARE) IS A MASSHEALTH PROGRAM THAT SUPPORTS INDIVIDUALS AGE 16 AND OLDER LIVING IN THE COMMUNITY WITH RELATED OR NON-RELATED FAMILIES. AFC PROVIDES MONTHLY HOME VISITS FROM A NURSE AND SOCIAL WORKER, A TAX-FREE CAREGIVER STIPEND, ONGOING TRAINING AND TEACHING ON THE INDIVIDUAL'S DISEASE PROCESS, CAREGIVER STRESS, AND COORDINATION OF COMMUNITY RESOURCES. OUR AFC CAREGIVERS RECEIVE SUPPORT FROM OUR AFC TEAM TO PROVIDE THE BEST CARE AT HOME FOR THEIR LOVED ONE. NORTH REGION LONG TERM SUPPORT SERVICES PARTNERSHIP (NRLP) IS A PARTNERSHIP AMONG NORTHEAST ARC, BRIDGEWELL AND GREATER LYNN SENIOR SERVICES. NRLP PROVIDES LONG TERM SUPPORT SERVICES COMMUNITY PARTNER (CPC) SERVICES TO MASSHEALTH MEMBERS AGES 3-64 ENROLLED IN AN AFFILIATED ACCOUNTABLE CARE ORGANIZATION (ACO) OR MANAGED CARE (MCO) PLAN. CPC'S HELP ASSESS, RECOMMEND AND COORDINATE SERVICES FOR INDIVIDUALS THROUGHOUT THE NORTH SHORE AND MERRIMACK VALLEY. NORTHEAST ARC CURRENTLY PROVIDES SUPPORT TO THE NRLP THROUGH TRAINING, QUALITY ASSURANCE AND OTHER SUBJECT MATTER EXPERTISE. THE ARC TANK - NEARC'S ARCTANK, FUNDED THROUGH A DONATION, IS A SOCIAL INNOVATION CHALLENGE THAT ENCOURAGES APPLICANTS TO DEVELOP IDEAS THAT WILL POSITIVELY DISRUPT THE WAY DISABILITY SERVICES ARE OFFERED. APPLICANTS COMPETE FOR SUPPORT THROUGH A RIGOROUS YET STREAMLINED PROCESS OF APPLICATION REVIEWS AND A FINAL PRESENTATION TO EXPERTS FROM DIFFERENT DISCIPLINES. SINCE INCEPTION, ARCTANK HAS AWARDED FUNDS TO 10 INNOVATIVE APPLICANTS ADDRESSING AREAS INCLUDING CIVIL LIBERTIES, EMPLOYMENT AND ENTREPRENEURSHIP, CRITICAL SAFETY SKILL BUILDING, TECHNOLOGY AND EDUCATION FOR MEDICAL, ALLIED HEALTH AND FIRST RESPONDERS, IN 2020, ARCTANK WAS NOT HELD AS A RESULT OF THE RAPIDLY CHANGING ENVIRONMENT CAUSED BY THE PANDEMIC. BREAKING GROUNDS CAF WAS DEVELOPED TO PROVIDE EMPLOYMENT TRAINING AND EDUCATION FOR YOUNG ADULTS INTERESTED IN FOOD OR CUSTOMER SERVICES BUT HAD NO DIRECT EXPERIENCE IN THE FIELD. THE CAF LOCATION WAS SELECTED BY A NEEDS ASSESSMENT COMPLETED BY A LONG-TERM PARTNER, THE CITY OF PEABODY. JOINT EFFORTS BY BOTH ORGANIZATIONS HAVE MADE BREAKING GROUNDS CAF A RECOGNIZABLE NAME, ELEVATING THE PROFILE OF NEARC IN THE COMMUNITY AND REINVIGORATING PEABODY'S DOWNTOWN. ARCWORCS COMMUNITY ART CENTER IS AN INTEGRATED, CULTURAL RESOURCE LOCATED IN DOWNTOWN PEABODY. ARCWORCS' MISSION IS TO PROVIDE A LOCATION FOR PEOPLE OF ALL ABILITIES TO LEARN, EXPLORE, CREATE, EXHIBIT AND SELL THEIR ART. ARCWORCS HAS TWO GALLERY SPACES, A GALLERY SHOP AND STUDIOS TO ACCOMMODATE PAINTING, SCULPTURE, POTTERY AND OTHER VISUAL MEDIUM CLASSES. ARCWORCS ALSO CONNECTS PEOPLE SUPPORTED BY NORTHEAST ARC TO THE LOCAL CREATIVE ECONOMY, WHICH GENERATES MULTI-BILLIONS OF DOLLARS IN SALES AND EMPLOYS OVER 20,000 PEOPLE ACROSS THE REGION. LOCATED INSIDE ARCWORCS IS THE HERITAGE CANING COMPANY, A STOREFRONT CHAIR CANING BUSINESS EMPLOYING PEOPLE WITH DISABILITIES, SHINE JEWELRY STUDIO AND PEABODY'S BLACK BOX. THE PERSONAL CARE ASSISTANCE FISCAL INTERMEDIARY PROGRAM PROVIDES PAYROLL AND BILLING SERVICES TO MORE THAN 10,000 INDIVIDUALS ACROSS THE STATE OF MASSACHUSETTS RECEIVING PCA SERVICES (PRIMARILY THROUGH MASSHEALTH) FOR HANDS-ON ASSISTANCE WITH SELF-CARE TASKS AND ACTIVITIES OF DAILY LIVING. INCLUDED IN THE PROGRAM EXPENSES AND REVENUE IS \$253,156,266 RELATED TO THE ACTUAL PAYROLL OF OVER 13,000 ACTIVE PCA WORKFORCE AND THE BILLING TO MASSHEALTH AND OTHER SENIOR CARE OPTIONS PROGRAMS. PART OF OUR FI SERVICES INCLUDE RECEIVING AND PROCESSING OVER 300,00 PCA ACTIVITY FORMS/TIMESHEETS AND ISSUING PAYMENTS TO THE PCAS AS WELL AS PROVIDING OUTSTANDING CUSTOMER SERVICE THROUGH OUR CALL CENTER TO ALL INDIVIDUALS IN OUR PCA FI PROGRAM WITH OVER 190,000 CALLS RECEIVED IN THIS PAST YEAR.
