The outstanding balance on the loans was \$20,000 at September 30, 2019. Future principal balances due are \$20,000 in 2020. During the year ended September 30, 2019, the Boston Plastic and Oral Surgery Foundation, Inc (the Foundation) entered into a promissory note in the amount of \$572,680 with the President of the Foundation, John G. Meara, MD, DMD, to purchase common stock in the Longwood Medical Trust (LMT) on behalf of the PO. The LMT requires that each shareholder be a physician. An agency agreement was executed between the Foundation and the President to meet the shareholder requirement. The President's interest in LMT cannot be sold without the written consent of the PO. LMT retains the right of first refusal to repurchase the stock if the President is incapacitated, files for bankruptcy, ceases to be employed by an affiliated Foundation of Boston Children's Hospital, or dies. However, the Foundation has the right to assign a replacement purchaser upon triggering of any right of first refusal of LMT to repurchase the share.
