United Way's partner programs in Basic Needs meet the most fundamental of human needs for those struggling to make ends meet including food, clothing, transportation and shelter, provide emergency shelter to victims of domestic violence, provide housing with support services, and provide emergency financial and heating assistance. The New London County Fund to End Homelessness focuses on rapidly rehousing individuals and families who are experiencing homelessness as well as keeping those who are at risk of homelessness in their current housing without ever having to enter shelter. The goals are to reduce the length of time individuals and families stay in shelters, reduce new episodes of homelessness, and reduce return entries into homelessness. Families and individuals experiencing homelessness or are struggling with losing their housing face many barriers. The first call for help is to United Way 2-1-1 where a Housing Specialist will determine if someone is either homeless or imminently homeless. The individual or family is referred to Eastern Connecticut's Coordinated Access Network for an intake appointment where all possible alternatives to shelter are explored. United Way is the administrator of the program. Direct housing and supportive services are provided by 5 area organizations: TVCCA, Always Home, Covenant Shelter, New London Homeless Hospitality Center and Norwich Human Services. Service providers work the premise that shelter should be used as a last resort. This may involve mediation with a family or landlord, problem-solving guidance, connection to community resources, and financial assistance for past-due rent, security deposit, or similar costs.
