THIS WILL EXPAND THE AGENCY'S REFERRAL NETWORK AND MAKES THE AGENCY ELIGIBLE TO RECEIVE FINANCIAL INCENTIVES FROM SSA FOR PLACING ELIGIBLE CLIENTS IN COMPETITIVE EMPLOYMENT. THE PSYCHOSOCIAL REHAB CENTER SERVED 439 INDIVIDUALS. DAILY ATTENDANCE RANGED FROM A LOW OF 20 ON WEEKENDS TO A HIGH OF 120 MONDAY-FRIDAY. THE CENTER PROVIDES DAILY STRUCTURE, RECREATION, SUPPORTIVE COUNSELING, WELLNESS ACTIVITIES, ART, WRITING, AND MUSIC GROUPS WITH THE OVERARCHING GOAL TO GIVE CLIENTS A POSITIVE WAY TO STRUCTURE THEIR DAY AND FORM CONNECTIONS TO PEERS AND THE GREATER COMMUNITY.
