URI's Urban Center for the Developmentally Disabled (UCDD), a transitional employment and training program for individuals diagnosed with mild retardation, has provided work readiness training, job placement, one on one job coaching, and ongoing case management to participants in an effort to increase independent levels of functioning. Domestic Violence Programs and Services - Serving nearly 1500 clients (adults and children), URI is one of the largest and most comprehensive domestic violence service providers in New York City. The organization runs six shelters with more than 600 beds. URI operates both emergency shelters, which help and house survivors immediately following their escape from abuse, and transitional shelters, which help survivors as they readjust back into the community. Our residential programs provide in-home-like community environments, with the ultimate goal of providing survivors with the tools they need to rebuild their lives and thrive. URI is also the only shelter in NYC that provides a co-sheltering model for survivors to heal in a safe environment with their pets. We offer job training, economic empowerment programs, counseling, legal assistance for survivors and their families, and as well as trauma-informed batterer intervention services.

Adults with Developmental Disabilities-URI manages two types of residential services for individuals diagnosed with intellectual and developmental disabilities. Intermediate Care Facilities (ICF) and Residential Alternative (IRA). In 2016, ICF served a total of 25 adult men and women and IRA served 8 adult men and women. All residences offer person-centered planning and care coordination as well as a wide variety of services, including transportation to and from day programs, community integration and recreational activities, nutritional, occupational, and physical therapies, and speech services. These residential facilities are certified by the office for People with Developmental Disabilities and have specially trained employees assigned to them 24 hours a day.

---

### **Form 990, Part III, Line 4c:**

Homeless Families Program and Services-URI began operations of new programs for homeless families in Harlem and in Queens in 2016. The Harlem Family Residence operates as a Tier II facility, providing 32 families with safe and secure transitional housing and access to comprehensive support services. The program for homeless families with children in Harlem and in Queens provides temporary, emergency shelter and supportive services to 56 homeless families with children. Modeled after our superior care and knowledge of emergency services in domestic violence, URI's approach to working with homeless families includes completing assessments and individual living plans tailored to each individual family member's need, with focus on their level of functioning. In addition, based on the correlation of homelessness and domestic violence, URI includes in its assessment a focus on domestic violence and provides support efforts such as access to psycho-educational groups addressing domestic violence. With full-time case managers and housing specialists on staff, URI is able to create concrete plans and provide needed resources for families to get back on their feet and into affordable housing.
