Domestic Violence Programs and Services - Serving nearly 2,500 clients, both adults and children, Urban Resource Institute (URI) is the largest domestic violence shelter provider in the country. The organization currently oversees 12 shelters with 1,183 beds on any given evening. URI operates both emergency shelters, which help and house survivors immediately following their escape from abuse, and transitional shelters, which help survivors as they prepare to re-adjust back into the community. Our residential programs create a safe and comfortable community environment, with the ultimate goal of providing survivors with the tools they need to rebuild their lives and thrive. URI is also the only organization in New York City that provides a co-living model for survivors to heal in a safe environment with their pets. We offer ancillary services including housing placement, economic empowerment programs, counseling, and legal assistance.

Form 990, Part III, Line 4b:

Programs for Homeless Families - URI has had ongoing success in the provision of services and the enhancement of our programs to serve homeless families with children. On July 1, 2018 we officially assumed operation of Adams I & II locations in Harlem, servicing 79 families with children at any given time. The program is flourishing providing case management, recreation and structured socialization and assistance with identifying permanent housing. URI also assumed operations of City View, September 2018, a commercial hotel that houses 71 families with children in Long Island City. Across all of URI homeless division sites from January 2018 - December 2018 we served 1,206 families, 1,412 adults and 2,187 children and placed 206 families into permanent housing. Overall, URI maintains high functioning programs provides quality services to the families and children we serve.

Adults with Developmental Disabilities - URI manages two types of residential services for individuals diagnosed with intellectual and developmental disabilities. Intermediate Care Facilities (ICF) and Individualized Residential Alternative (IRA). In 2018, URI converted ICF's to IRA's as required by the Office for People with Developmental Disabilities (OPWDD), with an intention to complete the conversions the end of 2019. All residences continued to focus on offering person-centered planning and a wide variety of services, including transportation to and from day programs, community integration and recreational activities, nutritional, occupational and physical therapies and speech services. These residential facilities are certified by OPWDD and specially trained staff is assigned to them 24 hours a day.
