REPEAL OF IRC SECTION 512(A)(7) STATEMENT

THE FUND FOR PUBLIC SCHOOLS , INC. (THE "ORGANIZATION") IS FILING AN AMENDED 2018 FORM 990-T TO CLAIM REFUND OF UNRELATED BUSINESS TAX PAYMENTS OF \$284 MADE WITH RESPECT TO CERTAIN QUALIFIED TRANSPORTATION FRINGE BENEFITS UNDER SECTION 512(A)(7) FOR THE FISCAL YEAR ENDED JUN 30, 2019. THE ORGANIZATION MADE TIMELY DEPOSIT(S) OF THE ESTIMATED PAYMENTS AND FILED THE ORIGINAL 2018 FORM 990-T BEFORE SECTION 512(A)(7) WAS RETROACTIVELY REPEALED BY THE TAXPAYER CERTAINTY AND DISASTER TAX RELIEF ACT OF 2019 SIGNED INTO LAW IN DECEMBER 2019.
