Prospect Park Alliance offers educational programs teaching visitors about the natural world and its stewardship, helping to support the Alliance's mission to maintain the Park as a resource for New York City, especially those New Yorkers from underserved and low to mid-income neighborhoods. The Park's Audubon Center and Lefferts Historic House Museum provide important educational and cultural programming for both schools and the public. During fiscal year 2019, 15,014 people visited the Prospect Park Audubon Center and an additional 74,047 people visited Pop-up Audubon I and II, innovative programs offering mobile presentations in various locations throughout the Park. The Lefferts Historic House Museum had public visitation totaling 31,735. Prospect Park also has a very active Volunteer Corps that is made up of community members who donate their time and energy and are critical to the ongoing maintenance and restoration of the Park. Over 2,616 volunteers contributed 17,049 hours to the Park including 176 outdoor cleanups.
