Since introducing this program to the community in 2006, UBCF has assisted over 60 women with breast reconstructive surgery. It is imperative for a women recovering from breast cancer to have every opportunity to regain her confidence. For many women whove had mastectomies, their natural inclination is to have reconstructive surgery as an effort to regain a sense of well-being, of moving on and forward with their lives. Unfortunately, breast reconstructive surgery is not covered by most medical insurance plans, as it is considered an elective surgery, even for a woman who has had to have a mastectomy due to breast cancer.
