VOLUNTEER PROGRAM IN 2019, 2,869 VOLUNTEERS CONTRIBUTED 7,353 HOURS OF SERVICE TO OUR PARKS. THIS IS EQUIVALENT TO AN INCREDIBLE \$214,389.75 WORTH OF INVESTMENT OF SWEAT EQUITY INTO WESTCHESTER'S PARKS, ACCORDING TO THE INDEPENDENT SECTOR'S ESTIMATE OF THE VALUE OF VOLUNTEER TIME IN NEW YORK STATE.
