The Association's CFO provides reports on the previous 12 rolling-quarters average value of assets to help determine the distribution from the Foundation to the Association for the following fiscal year. The payout has generally been between 4% and 6% of the average 12 rolling-quarter average value of assets. The Foundation's board communicates regularly with the CFO of the Association regarding the Foundation's investments and plans for distributions. The Foundation's quarterly investment statements are prepared for, and reviewed by the Foundation's Board (including the CEO of the Association).</p>
