IN ADDITION, THE INSTITUTE OPERATES AN ART & DESIGN RESEARCH LIBRARY WHICH IS OPEN YEAR-ROUND AND SERVES THE INSTITUTE'S STAFF, STUDENTS, FACULTY, AND MEMBERS; THE GENERAL PUBLIC; AND OUTSIDE SCHOLARS. IN 2021, THE LIBRARY SERVED 2,171 PATRONS, AND CIRCULATED 998 ITEMS. IT WAS CLOSED FOR 132 DAYS AND SUPPORTED PRATTMWP CLASSES THAT WERE HELD VIRTUALLY FOR EIGHT MONTHS. THE LIBRARY PROVIDES REFERENCE, RESEARCH, AND CIRCULATION SERVICES, CLASS AND INDIVIDUALIZED INSTRUCTION, COMPUTER AND DATABASE ACCESS AND TRAINING, INTERLIBRARY LOANS, SPECIAL EVENTS, TOURS, AND EXTENDED HOURS. ITS COLLECTIONS INCLUDE 29,794 BOOKS, 20 PERIODICAL SUBSCRIPTIONS, 3,351 MUSIC COMPACT DISCS, 2,578 FILMS ON DVD AND VHS, AND 2,929 ARTISTS FILES. THE CATALOG OF COLLECTION HOLDINGS IS SEARCHABLE ON-SITE AND THROUGH THE INSTITUTE'S WEB PAGE. THROUGH ITS AFFILIATION WITH THE PRATT INSTITUTE LIBRARIES, PATRONS HAVE ACCESS TO 176 ONLINE ARTICLE, EBOOK, IMAGE, AND STREAMING VIDEO DATABASES. RESEARCH, INTERLIBRARY LOAN, AND SCANNING SERVICES CONTINUED TO BE OFFERED REMOTELY TO ALL PATRONS. CONTACTLESS CURBSIDE PICKUP AND RETURN SERVICES HAVE BEEN AVAILABLE SINCE EARLIER IN THE YEAR AND WILL BE OFFERED INDEFINITELY.

NUMEROUS GIFTS AND SEVERAL PURCHASES WERE ADDED TO THE MUSEUM OF ART'S PERMANENT COLLECTION, INCLUDING AN IMPORTANT GLASS VASE BY FRANCOIS-EMILE DECORCHEMENT; AN EXPRESSIVE ROCKING CHAIR BY THE HEYWOOD BROTHERS; A RARE DAGUERRETYPE OF TRENTON FALLS; ALONG WITH SEVERAL WORKS IN MODERN AND CONTEMPORARY ART. THE ARTS HAVE HELPED TO SUSTAIN US THROUGH THE GLOBAL PANDEMIC AND DEMONSTRATED THE POWER OF VISUAL CULTURE TO EXPRESS EMOTION, CALL ONE TO ACTION, AND EXPLORE OUR COMMON GROUND AND HUMANITY.
