Youth Services - Objective: To provide leadership development, social activities and crisis intervention to LGBTQ identified youth ages 13-20. The program also provides consultation, intervention and education to youth serving providers to ensure LGBTQ inclusion. Services include support groups, health chats, evening, after school and weekend activities, and tutoring to support educational goals. Annual events include the Youth Pride celebration, and the Big Queer Prom. Library and History - The Library and Archives has a collection nearly 10,000 items. Shoulders to Stand On is a documentary project that captures the stories, struggles, and achievements of the LGBTQ pioneers. Gallery Q - Gallery Q provides the Gay Alliance the ability to highlight LGBTQ art and artists. The exhibits change monthly for an opening as part of the First Friday Program, a partnership between several nearby art galleries. Other program services are primarily supported by contributions.
