A study of 31 nonprofit organizations that participate in fundraising training showed that their public support on Giving Hearts Day increased over a seven year period from \$804,318 in donations in 2009 to \$2.64 million in donations in 2016. In 2016, the Institute expanded the ability of charity organizations to solve complex community challenges through its training and coaching. The Institute trained nearly 300 organizations particularly in fundraising. Many continued their professional development in the fundraising curriculum developed by FundingLogic through coaching programs conducted by the founders to build a mastery of fundraising and leadership. Grant Writing Services. Since 2005, the Foundations have supported grant writing assistance for health-related nonprofit organizations to generate additional financial resources for their programs. Since the formal addition of grant writing assistance, the Foundations and other regional nonprofit organizations have secured over \$25.4 million in grant funding.
