As a result of participating in fundraising training, a study of 23 nonprofit organizations showed community support on Giving Hearts Day increased over a ten-year period from \$380,000 in donations in 2008 to \$1.93 million in donations in 2018. Grant Writing Services. Since 2005, the Foundations have supported grant writing assistance for health-related nonprofit organizations to generate additional financial resources for their programs.
