The goal of the employment unit is to provide students with valuable on-site work training, off-site internships, job preparation classes and career counseling, job development and placement in gainful employment in the community. In the employment unit, we provided 6,429 hours of direct instruction to students. Staff provided the following classes to teach employment skills: Vocational Preparation, Job Keepers, and Career Choices. We were able to place students in 22 internships in 2017. These internships are jobs in the community but the wages are paid by ScenicView Academy. We were successful in placing over 28 students in jobs in the community.

Form 990, Part III, Line 4b:

Clinical services includes individual and group psychotherapy services, and recreational therapy services. The vision of clinical services is that self-knowledge and connectedness empowers individuals to change their world. Our mission is to provide opportunities for individuals with Autism Spectrum disorders and other learning disabilities to increase emotional, social, and cognitive skills that lead to a more successful interdependent life. In the clinical unit, we provided 2,755 hours of direct instruction to students. Employees in the clinical unit presented at and attended various conferences in Utah. Two clinical staff member conducted our first ever two day training on Social Steps. Clinical interns assisted in creating Dialectical Behavior Therapy (DBT) binder that included handouts and worksheets. Once the binders were created the DBT training was provided to all clinical staff.

Form 990, Part III, Line 4c:

In the residential unit, we provided 7,971 hours of direct instruction to students in the area of personal care, nursing, benefits, budgeting, on and off campus housing and independent living skills development. During 2017, 35 new students were admitted and all were supported by staff in the residential unit. New transportation processes were developed and implemented by residential staff, these changes have led to students getting bus passes and utilizing public transportation. The ScenicView Shuttle was created to provide students with transportation to various places in the community during the evening hours.
