The goal of the employment unit is to provide students with valuable on-site work training, off-site internships, job preparation classes and career counseling, job development and placement in gainful employment in the community. In the employment unit, we provided 8,480 hours of direct instruction, and we had 3600 hours of indirect instruction that helped us provide the best possible care to the students. Staff provided the following classes to teach employment skills: Pre-Work meetings, Job Finders, 1-on-1s, and collaborations when needed. We were able to place students in 26 internships in 2018. These internships are jobs in the community but the wages are paid by ScenicView Academy. We were successful in placing over 21 students in jobs in the community. We have spent more than 50 hours, assisting students in the administration of their You Science assessment, which will help them to find a career.

Core services includes individual counseling, biofeedback, speech therapy, executive function tutoring, and behavioral interventions in addition to group psychotherapy services (e.g. support group, couples counseling, roommate counseling). The vision of clinical services is that self-knowledge and connectedness empowers individuals to change their world. Our mission is to provide opportunities for individuals with Autism Spectrum Disorders and other learning differences to increase emotional, social, and cognitive skills that lead to a more successful interdependent life. Within the core path, we provided 1,318 hours of individual therapy and 2,444 more hours of direct instruction to students. These additional hours included classes, activities, and other interventions to address situations and students concerns. Furthermore, speech therapists spent 447 hours working directly with students to help them with various communication needs. We also continue to evaluate the effectiveness of our services and be mindful of various methods we may use to improve efficiency moving forward. Employees in the core unit attended and presented at various conferences in Utah. The number of staff within our department has also continued to increase, allowing us to provide additional services to students.

During 2018, 55 students were given support as they researched options for higher education in the Educational Exploration class or during a scheduled one on one with our Outside Education specialist. Two students graduated from their postsecondary programs. Our library had over 1300 items checked out in 2018 and was staffed entirely by our students.
