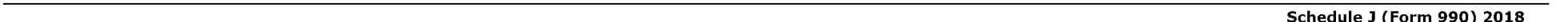

Part I, Lines 4a-b	<p>Robert P. Steigmeyer, President & CEO, participated in a 457(f) plan with Concord Hospital during the fiscal year. Under the terms of the plan, after a three-year vesting period a 457(f) amount is included in taxable W-2 wages for Mr. Steigmeyer. The calendar year ending within the Hospital's current reporting period ending September 30, 2019 (tax year 2018) was the second year where amounts previously set aside as deferred under his 457(f) plan had vested. Accordingly, \$121,300 was included in Mr. Steigmeyer's 2018 W-2 taxable wage which was previously reported on Schedule J, Part II, Column C of the Hospital's Form 990 filing for fiscal years ending September 30, 2016, and September 30, 2017. In accordance with IRS instructions, this amount has been included in Schedule J, Part II, Column B (iii) and Column F. There were additional contributions to Mr. Steigmeyer's 457(f) plan for fiscal years ended September 30, 2015, 2016, 2017, 2018, and 2019 of \$115,000, \$120,000, \$125,000, \$130,000, and \$140,000, respectively. Each contribution plus earnings will be reported in Mr. Steigmeyer's W-2 after a three-year vesting period. The amount included in Mr. Steigmeyer's deferred compensation amounts in Schedule J, Part II, Column C include the \$130,000 contribution to his 457(f) plan plus \$31,647 of earnings. Effective in April of 2019 and during the fiscal year covered by this return, Dr. Gerald Sardella ceased employment with Concord Hospital. As per the terms of his separation agreement, he was paid his regular salary for six months and one week as severance. As these payments were made to him after the calendar year ending within the current fiscal year, these payments are not reflected in Schedule J, Part II which reports compensation and benefits based on calendar yearend 2018. Dr. Sardella's total severance payments of \$321,915.60 will reported in his 2019 Form W-2 as part of his Box 5 taxable wages.</p>
