IN ADDITION, THEY DISCUSSED SOME OF THE WAYS THAT FAMILIES WITH MODERATE INCOMES ARE STRUGGLING TO PAY THEIR BILLS AND ACCESS HEALTH CARE DUE TO HIGH HOUSING COSTS, MEDICAL BILLS, AND OTHER EXPENSES, WHILE STILL HAVING TOO MUCH INCOME TO QUALIFY FOR AID PROGRAMS. CONSUMERS AND SOCIAL SERVICE PROVIDERS ALIKE REPORT THAT IT IS VERY CHALLENGING TO FIND PRIMARY CARE PROVIDERS WHO ACCEPT MEDICAID. MARY SERVICE AREA WERE SIGNIFICANTLY LESS LIKELY TO NOT SEEK CARE DUE TO COST (8%). OTHER EFFORTS DURING COVID INCLUDED COVID MITIGATION AND EDUCATION FOR BOTH PROFESSIONAL ORGANIZATIONS AND COMMUNITY. COVID MITIGATION INCLUDED: 1) 6,216 COVID TESTS WERE PERFORMED VIA DRIVE THROUGH TESTING AT TWO OUTDOOR LOCATIONS: TENT TESTING OFFERED ADJACENT TO ST. MARY ED AND AT CENTRALLY LOCATED PRIMARY CARE PRACTICES EASILY ACCESSIBLE BY THE COMMUNITY. ST. MARY INVESTED \$210,631 IN OUTDOOR TESTING. 2) 25,106 MASKS AND 3,000 EDUCATIONAL FLYERS WERE DISTRIBUTED TO HELP ADDRESS SAFETY DURING COVID. COVID EDUCATION INCLUDED: 1) CONTINUING CARE FACILITIES STAFF - INFECTION PREVENTION AND COPING WITH EMOTIONAL STRESS DURING THE COVID-19 PANDEMIC PROGRAMS WERE DEVELOPED FOR 17 LOCAL SKILLED NURSING FACILITIES (SNFS), ALONG WITH SUPPORT FROM GRIEF COUNSELORS. 2) VIRTUAL EDUCATION SESSIONS FOR COMMUNITY MEMBERS - A TOWN HALL WITH A ST. THESE MEMBERS ARE SELECTED BASED ON THEIR PERSONAL QUALIFICATIONS AND KEY COMPETENCIES AND THEIR COMMITMENT TO ST. MARY MINISTRIES AND VALUES.</p>
