THE INTERESTED PERSON MUST DISCLOSE IN WRITING OR VERBALLY AT A BOARD OF DIRECTORS MEETING THAT THERE IS AN EXISTENCE OF A CONFLICT OF INTEREST AND THE NATURE OF HIS OR HER CONFLICT OF INTEREST. THE BOARD OF DIRECTORS SHALL, IF APPROPRIATE, INVESTIGATE ALTERNATIVES TO THE ACTUAL OR PROPOSED TRANSACTIONS OR ARRANGEMENTS. AFTER EXERCISING DUE DILIGENCE, THE BOARD OF DIRECTORS SHALL DETERMINE WHETHER BEDCO CAN OBTAIN A MORE ADVANTAGEOUS TRANSACTION OR ARRANGEMENT WITH REASONABLE EFFORTS FROM A PERSON OR ENTITY THAT WOULD NOT GIVE RISE TO A CONFLICT OF INTEREST.
