PERHAPS THE GREATEST ACCOMPLISHMENT FOR FY20 IS THE SUCCESS OF THE FIRST-EVER COFC DAY ON JANUARY 30 24 HOURS DURING WHICH DONORS SUPPORTED THE COLLEGE TO THE TUNE OF \$5 MILLION. THE DONATION GOAL WAS \$1 MILLION, YET MORE THAN 1,400 ALUMNI, FRIENDS, FACULTY, STAFF, AND STUDENTS RALLIED TO MAKE THE FIRST-EVER COFC DAY A SUCCESS THIS MANY DONORS IN ONE DAY IS A RECORD AT THE COLLEGE. HOWEVER, COFC DAY WAS ABOUT MORE THAN DRIVING DONATIONS TO THE COLLEGE. THE DAY WAS CREATED TO INSTILL PRIDE AND SPIRIT INTO THE HEARTS AND MINDS OF THE 90,000 ALUMNI. THE ALUMNI ASSOCIATION WORKED TO ENGAGE ALUMNI AROUND THE WORLD TO PARTICIPATE IN COFC DAY. SIXTEEN ALUMNI CLUBS GARNERED BETWEEN 600-700 PARTICIPANTS TO GATHER ON THAT DAY IN LOCALES LIKE LONDON, ENGLAND; WASHINGTON, D.C.; BOSTON, MASS.; AND ATLANTA, GA. AS WELL AS GREENVILLE, COLUMBIA AND THE LOWCOUNTRY. WHILE THE FOUNDATION ENJOYED NUMEROUS ACCOMPLISHMENTS DURING THE LAST FISCAL YEAR, THE COVID-19 PANDEMIC THAT CAUSED REMOTE LEARNING AND WORKING TO BEGIN IN MARCH AND THAT CONTINUES TO IMPACT HIGHER EDUCATION, PRESENTED UNIQUE AND LIKELY LONG-LASTING CHALLENGES TO THE COLLEGE AND THE FOUNDATION. WHILE THE FULL IMPACT OF THIS IS STILL UNKNOWN, BOTH THE FOUNDATION AND COLLEGE REMAIN COMMITTED TO ENSURING QUALITY AND SAFE EDUCATIONAL OPPORTUNITIES ARE AVAILABLE TO STUDENTS. THE MOST SIGNIFICANT CONTRIBUTION THE FOUNDATION MADE TO THE OVERALL EFFORTS WAS IN THE PROMOTION OF THE STUDENT EMERGENCY FUND AS A TOP PRIORITY AND THE EXPEDIENT DISTRIBUTION OF FUNDS RAISED TO HELP STUDENTS WHO NEEDED IT THE MOST. FROM MID-MARCH THROUGH THE SUMMER, THE FOUNDATION SECURED NEARLY \$180,000 FROM THE COLLEGE OF CHARLESTON COMMUNITY TO SUPPORT THE STUDENT EMERGENCY FUND. AND, ALL OF THE FUNDS RAISED DURING THAT TIME WERE DISTRIBUTED TO MORE THAN 1,000 STUDENTS WHOSE FINANCIAL CIRCUMSTANCES WERE DIRE BECAUSE OF THE PANDEMIC. FROM JOB LOSS AND LACK OF RESOURCES FOR DISTANCE LEARNING TO OUTSTANDING MEDICAL BILLS AND BASIC NEEDS SUCH AS GROCERIES, THE REASONS STUDENTS REQUIRED HELP WAS WIDE-REACHING; AND THE FOUNDATION'S CAPABILITY TO GET GRANTS INTO STUDENTS' HANDS WAS CRITICAL. THE STORIES OF INSPIRATION AND MOTIVATION THAT TAKE PLACE BEHIND THE FIGURES SHOWCASES HOW GIVING IMPACTS THE COLLEGE OF CHARLESTON CAMPUS.
