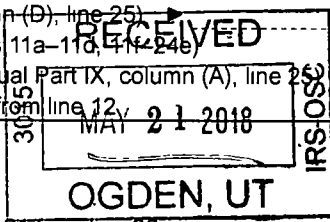

As a result, it was determined that land held in unrestricted and endowment fund, was held for amounts in excess of fair value. The foundation transferred this land to held for sale and adjusted the cost to market value, resulting in an impairment of \$38,969.
