LACADA was founded by a local physician Dr. Ethan Allen, who remains involved with the agency and is currently serving as board vice-president. The agency treated 200 clients in the first year and is currently serving more than 5,500 individuals annually. The mission of LACADA is a commitment to saving lives, empowering individuals and families, and strengthening communities through innovative, client-centered, culturally sensitive substance use and behavioral health services. In addition, LACADA completed a transition to integrated healthcare services, and standardized the use of evidence-based prevention and treatment practices in all agency programs. The Custody to Community Transitional Reentry Program - The CCTRP Program successfully completed their 3-year contract and was awarded an additional 3 years of which they are in their 2nd year. CCTRP at LACADA currently serves incarcerated women with 45 days to 2 years remaining on their sentence by providing them a transitional living facility located in Santa Fe Springs. During their stay, they are provided with counseling and support services to better enable their success in the community upon full release. CCTRP works to ensure that clients leave with the ability to live a crime/drug-free lifestyle, become gainfully employed, and strengthen family relationships, all of which reduce rates of recidivism. The shame associated with a SUD during pregnancy and motherhood can be overwhelming and Alice's House provides a safe home-like environment to learn new parenting skills while simultaneously treating their addiction. The Santa Fe Springs Outpatient and Intensive Outpatient Services are provided in both English and Spanish by culturally competent staff members and include, case management, crisis intervention, individual counseling, group counseling, family counseling, support groups, instruction in prevention and diversion strategies and workshops in health education, life skills and parenting classes. Santa Fe Springs Outpatient serves 800 clients annually with 25 full-time staff, 4 part-time staff, and 14 interns. The main address (11015 Bloomfield Ave, Santa Fe Springs, CA 90670) also holds 2 field based service locations where staff will provide treatment services to patients who are active in other types of programs that don't offer SUD services. The two field based service locations are connected to Victory Starts Now and Christ Center Ministries who are both transitional living homes. The Downtown Los Angeles Outpatient Services, also provides individualized counseling services, treatment planning, and case management for a variety of disorders. The most striking difference between this program and its corresponding program site in Santa Fe Springs is the Downtown was created to combat homelessness, due to the facility's close proximity to Skid Row. LADADA serves approximately 700 clients annually at this location, with 25 full-time and 2 part-time staff members. Youth Services encompasses court-approved substance use treatment programs for adolescents (ages 13-17), transitional age youth (ages 18-20), as well as prevention and education services provided to schools in the cities of Whittier and Santa Fe Springs and a school based location at El Rancho High School in Pico Rivera.
