WE ARE A CHRISTIAN CHURCH AND WE OFFER A CHRISTIAN TRAINING PROGRAM, WHICH IS FOR ANYONE WHO IS SERIOUS ABOUT FOLLOWING JESUS. WE ENCOURAGE THEM SO THAT THEY MAY CONTINUE AS SERIOUS CHRISTIANS. A LARGE PART OF OUR OPERATION IS TO FUND OUR MISSIONARY WORK IN THE IMPOVERISHED COUNTRY OF HAITI, WI. WE HAVE BEEN IN HAITI SINCE 1977 AND ARE RECOGNIZED AS AN NGO BY THE HAITIAN GOVERNMENT. WE OPERATE 2 ORPHANAGES WHERE WE ARE THE SOLE SUPPORT OF ALMOST 200 CHILDREN AND IN ADDITION WE CONDUCT WEEKLY FEEDING IN THE MORE REMOTE MOUNTAINOUS REGIONS OUTSIDE PORT-AU-PRINCE. WE TAKE IN CHILDREN WHO ARE IN DESPERATE SITUATIONS. MANY OF THEM WERE VERY CLOSE TO DEATH WHEN WE TOOK THEM IN. MOST OF THEM BECOME VERY HEALTHY CHILDREN. ALTHOUGH SOME DO HAVE HANDICAPS FROM BEING SO MALNOURISHED. OUR GOAL IS TO RAISE THE CHILDREN TO BECOME RESPONSIBLE HAITIAN CITIZENS AND HOPEFULLY CHRISTIANS WHO WILL IN TURN HELP THEIR COUNTRY.
