Under the terms of a Separation Agreement dated March 24, 2017, and in exchange for a general release of claims and a confidential and proprietary developments acknowledgement, Mr. Arnt received a lump sum payment of \$112,500, less applicable taxes. Jason Burum was the Chief Client Officer for Healthwise. Under the terms of a Separation Agreement dated March 24, 2017, and in exchange for a general release of claims and a confidential and proprietary developments acknowledgement, Mr. Burum received a lump sum payment of \$106,850, less applicable taxes. Neal Benz was the Vice President of Technology and Operations. Under the terms of a Special Voluntary Resignation Program, and in exchange for a general release of claims and a confidential and proprietary developments acknowledgement, Mr. Benz received a severance payment of \$96,492, less applicable taxes. Leslie Kelly Hall was the Senior Vice President of Policy. Under the terms of a Special Voluntary Resignation Program, and in exchange for a general release of claims and a confidential and proprietary developments acknowledgement, Ms. Kelly Hall received a severance payment of \$108,300, less applicable taxes. On July 22, 2011 the Organization entered into a retention agreement with its President and Chief Operation Officer (COO), James Giuffre, to provide incentive compensation to him to continue his employment with the Organization. Under the terms of this agreement, the Organization will pay the COO a lump sum payment of \$300,000 provided he remains employed by the Organization through July 15, 2017. Schedule J, Column C and Part VII, Section A, Form 990 include \$22,916 of accrued compensation for the calendar year 2017 and Column B(ii) includes a payment totaling \$300,000 in calendar year 2017. In April 2014, the Organization entered into a retention agreement with its Chief Science Officer, Michael Barry, to provide incentive compensation to him to continue his employment with the organization. Under the terms of this agreement, the Organization will pay the CSO a lump sum payment of \$250,000 provided he remains employed by the Organization through April 1, 2019. Also, the agreement provides for the lump sum payment if his employment is terminated prior to the retention date due to death, disability, specified change of control events or by the employee for good reason or by the Organization for other than cause (as specified and defined in the agreement). In March of 2017 as part of a grant to Massachusetts General Hospital, Mr. Barry left Healthwise to work on the grant at MGH. This event triggered payment of the retention agreement. Schedule J, Column B(ii) and Part VII, Section A Form 990 includes a payment totaling \$250,000 in calendar year 2017. On February 25, 2016 the Organization entered into a retention agreement with Robert E. Kyte, CEO, to provide incentive compensation to continue his employment with the Organization. Under the terms of the agreement, the Organization will pay the CEO a lump sum of \$375,000 provided he remains continuously employed until June 1, 2021. Schedule J, Column C and Part VII, Section A, Form 990 include \$75,000 of accrued compensation for the calendar year 2017.</p>
Part I, Line 5	<p>In order for Healthwise to meet its mission of maximizing delivery of consumer health information and tools, Healthwise works with a variety of organizations that are active in the field of health education ranging from other nonprofit organizations to for-profit web portals. In order to accomplish this exempt mission, a small number of our employees are charged with the assignment of enhancing our distribution through building relationships with these organizations. The compensation plans are designed to bring sales incentive compensation into alignment with Healthwise's strategy emphasizing the achievement of our mission by increasing market share growth through new client acquisition. In developing the plan, Healthwise follows the principles of respect, teamwork, and do the right thing. These Healthwise employees' compensation is based partially on the results of their efforts tied to gross revenues received. It should be noted that none of the compensation is paid on net earnings. The setting of these employees' total compensation is reviewed carefully in comparison to market studies as benchmarks for reasonableness.</p>
Part I, Line 7	<p>If the mission accomplishment is achieved, the Board takes into account the financial capabilities of Healthwise to pay such additional compensation so as not to jeopardize its operating ability, as well as reviews total compensation to assure that all compensation falls within the reasonable remuneration factors as a tax-exempt organization. Once the Board establishes if there will be a payment and determines the percentage of base pay used to calculate such payment, then the formula used to determine the payment is applied to all employees, including officers. When paid, the amount of such mission based remuneration is a percentage of the employee's compensation.
