GOVERNED BY A BOARD OF TRUSTEES WHO ARE COMMUNITY VOLUNTEERS - BUSINESS AND INDUSTRY LEADERS, HEADS OF ORGANIZATIONS, PUBLIC SERVANTS AND WELL-MINDED CITIZENS - THE FOUNDATION PURSUES ITS PHILANTHROPIC ENDEAVORS WITH ZEAL AND COMMITMENT, KNOWING THAT THE SUCCESS OF THE HOSPITALS IS TIED TO THE SUCCESS OF THE FOUNDATION.
