


In addition, ESD's President and CEO, or his/her designee, serves as a non-voting, non-fiduciary advisory representative to the Board. The entities with the ability to appoint Board Directors, either before or after this change, have no power to control the Board's actions.

Under the bylaws amended in November 2016, the Corporation's Members may each remove Directors they appointed with or without cause. Members are also required to approve, after the approval by the Board of Directors, amendment of the Certificate of Incorporation, a merger or consolidation, dissolution of the Corporation and the sale of all or substantially all of the Corporation's assets. Members must both also approve the addition, amendment or repeal of the by-laws, and the adoption of new by-laws.
