Form 990, Part III, Line 4a:

The main accomplishment of FYE 8/31/19 was the production and presentation of 201 musical and multimedia events that were attended by 30,302 people. National Sawdust's 2018-2019 "SEASON FOUR" highlighted New Music--New Opera, New Jazz, New Pioneers in Contemporary Performances. These productions were the result of multiple programs being developed by National Sawdust --a Master Curator's Series, artist and group residencies, educational internships, and successful partnerships with other arts organizations. The performances were presented in the National Sawdust building, a state of the art music venue constructed within the renovated shell of a 100 year old sawdust factory in Williamsburg, Brooklyn.

Form 990, Part III, Line 4b:

In addition to the established Artists-in-Residence program which has helped over 40 groups in developing their careers, National Sawdust formally began a Projects-in-Residence program to concentrate on creating one specific concept or piece currently in development.
