ALMA IS A FORUM OF AFRICAN LEADERS WHERE THEY CAN TRACK THEIR PROGRESS, SHARE BEST PRACTICES AND ADDRESS CHALLENGES AS THEY FIGHT MALARIA IN THEIR COUNTRIES. THE ALMA SCORECARD FOR ACCOUNTABILITY AND ACTION AND THE ALMA 2030 SCORECARD TOWARDS MALARIA ELIMINATION ARE IMPORTANT MANAGEMENT TOOLS WHICH TRACK PROGRESS AND DRIVE ACTION.
