iMentor partners with public high schools in low-income communities, where a majority of students will be first-generation college graduates. We build mentoring relationships that empower students to navigate high school, succeed in college and achieve their highest ambitions. Every student in a school is matched with a college-educated mentor who commits to the program for a minimum of three years. Mentors and students build their relationship using the iMentor curriculum, which guides their weekly online communication and monthly in-person meetings. iMentor also provides its curriculum, technology, and best practices to nonprofits nationwide to help them run effective programs in the iMentor model. Since 1999, iMentor has connected more than 29,000 students with mentors in more than 30 communities.
