THE MUSEUM FACED UNIQUE CHALLENGES THROUGHOUT THE 2019-20 YEAR. THE FISCAL YEAR BEGAN WITH A TRAVELING EXHIBITION FEATURING PRINTS BY FRENCH IMPRESSIONIST EDGAR DEGAS. THIS EXHIBITION WAS PAIRED WITH MEANINGFUL NEW PROGRAMS OFFERED TO THE PUBLIC. A PARTNERSHIP WITH A PRINTMAKER FROM GEMINI GEL IN LOS ANGELES PROVIDED A PUBLIC LECTURE ON CONTEMPORARY PRINTMAKING; THE MUSEUM HOSTED A LECTURE WITH THE COLLECTOR OF THE DEGAS COLLECTION; AND THE EXHIBITION CULMINATED IN A CLOSING FUNDRAISING EVENT THAT SUPPORTED THE WORK OF THE MUSEUM. PERHAP THE GREATEST ACHIEVEMENT WAS THE CELEBRATION OF THE CCAE'S 25TH ANNIVERSARY. THE MUSEUM FEATURED AN EXHIBITION THAT CELEBRATED THE MUSEUM'S PERMANENT COLLECTION. THIS COLLECTION OF CONTEMPORARY ARTWORKS IS AN ECLECTIC SAMPLING OF THE EXHIBITIONS THE MUSEUM HAS HOSTED THROUGHOUT ITS TWENTY-FIVE YEARS. THIS EXHIBITIONS WAS THE FIRST TIME IN OVER A DECADE THAT THE PERMANENT COLLECTION HAS BEEN ON VIEW TO THE PUBLIC. IN ADDITION TO THE PERMANENT COLLECTION, THE MUSEUM BORROWED BACK ARTWORKS FROM THEIR FIRST SEASON OF EXHIBITIONS TO EXPLORE THE CONTUED RELEVANCE OF HIGHLIGHTING CONTEMPORARY ARTWORKS IN ESCONDIDO. THE 2019-2020 SEASON WAS CUT SHORT DUE TO COVID-19 CLOSURES, HOWEVER THE FINAL SHOW OF OUR SEASON WAS ENDANGERED: EXPLORING CALIFORNIA'S CHANGING ECOSYSTEMS. THIS EXHIBITION HIGHLIGHTED THE RELEVANCE OF ECO-ACTIVISM, AND EXPLORED THE RELATIONSHIP BETWEEN ARTISTS AND THE ENVIRONMENT. PARTICIPATION BY STUDENTS FOR OUR STUDENT GALLERY WALL WAS THE HIGHEST OF THE FISCAL YEAR, WITH NEARLY 80 STUDENTS IN MIDDLE AND HIGH SCHOOL SUBMITTING ARTWORKS FOR THE EXHIBITION.
