The Towers has been a part of the Medicaid waiver program through WRAAA since 2007 serving approximately 24 residents a month under this program which allows a qualified AL waiver recipient to receive rent subsidies affording them an apartment and all offered amenities. The Towers also serves persons with a VA benefit earned during armed conflict for which the veteran or the spouse receives a monthly stipend that is used for rent. The Towers is contracted with the PACE program, a Medicaid waiver program that also subsidizes qualified AL waiver recipients to afford monthly rent and provides physician services and medical care allowing residents to age in place. Throughout 2018 we averaged 40 residents on the PACE program. Our 2018 occupancy of 97% is well above national and state averages demonstrating our consistently high resident/family satisfaction.
