Disability Services - Staffed by expert pediatric therapists and clinicians, our integrated pediatric therapy services bring a family-focused approach to the treatment of developmental delays, disruptive behaviors and social, emotional and cognitive issues using a variety of methods, such as speech, language, feeding/ swallowing and occupational therapy, along with aqua and yoga therapy. Developmental social groups offer guided interaction with peers that helps children develop social skills. Customizing employment is more inclusive and provides adults with disabilities options beyond day programs and sheltered workshops by matching the strengths, conditions and interests of a job candidate and the identified business needs of an employer. Staff are trained in a special blend of flexible strategies, services and supports that are designed to increase employment options for job seekers with severe challenges who need a more individualized approach.
