SwedishAmerican Foundation (SAF) supports SwedishAmerican Hospital, a 501(c)(3) organization in its mission to provide quality medical healthcare to communities in Northern Illinois and Southern Wisconsin regardless of race, creed, sex, national origin, handicap, age or ability to pay. During the current year, SAF provided funding grants to specialized departments which helped enhance patient care and patient-visitor comfort. SwedishAmerican Health System partnered with Aunt Martha's Health & Wellness to provide Rockford area residents with greater access to essential medical services and help reduce escalating health care costs for taxpayers. SwedishAmerican Foundation provided a grant to the hospital to build an onsite clinic which will offer an integrated, holistic, coordinated approach to primary care, women's health services and mental health. SwedishAmerican partnered with Rockford Fire Department to form the Mobile Integrated Healthcare Initiative for the purpose of reducing non-emergency ambulance calls and emergency room visits. The pilot program identified a small group of individuals who over a 6 month period of time made frequent calls for emergency services. SwedishAmerican provided a RN case manager and Rockford Fire Department hired one of their own to manage the program. Those patient/frequent users who qualified for the program received in-home health and well-being assessments, and were provided support from numerous other medical and community resources already available and better qualified to manage the needs of these individuals. SwedishAmerican Foundation provided funding to the hospital for the RN case manager position.
